Conditions:

1. Utility easements shall be placed on lots as requested by utility companies.

- 2. Deed Restriction on 35 acres of parent parcel per Town Ordinance Standards.
- 3. Note on Final CSM. "No buildings which produce wastewater are allowed on lot 1 until acceptable means of wastewater disposal is approved by the necessary governmental agencies".
- 4. Dedicate a 40 foot half road right of way along W. Noss Rd. (as shown on preliminary CSM) at the discretion of the Town.

- 2. Proposed lot lines must include the system area with the buildings which utilize the system.
- 3. Note on Final CSM. "Lot 1 contains existing buildings which utilize an existing private sewage system at the time of this survey. However,

- soils on the lot may be restrictive to the replacement of the existing system".
- 4. Approval contingent on Town of Avon granting a conditional use permit to create Lot 1 with less than required road frontage.
- 5. Note on Final CSM "Lot 1 does not meet current minimum road frontage standards, therefore, no buildings which produce wastewater are allowed on Lot 1 until such time as it is made conforming to all zoning standards.
- 6. Final CSM shall be submitted to and approved by the Agency one year after the preliminary approval.
- 7. CSM's subject to local approval shall be recorded with the Rock County Register of Deeds within 6 months of their last approval.
