BE IT FURTHER RESOLVED, that the County Board chair shall appoint three members of the Rock County Board of Supervisors to the Committee in a manner consistent with RULE IV, subsections G. & H. of the Rock County Board of Supervisors Rules of Procedure.

BE IT FURTHER RESOLVED, that the Human Resources Director, or his or her designee, as well as a representative from Rock County's contracted employee benefits consultants shall be ex officio, nonvoting members of the Committee.
