• LD 2015 037 (Beloit Township) – Patch

Moved to approve with conditions by Supervisor Gustina, Seconded by Supervisor Davis. Passed (4-0).

Conditions:

- 1). Lot 2 receives access onto E. Inman Parkway from the Town of Beloit.
- 2). Lot 2 is provided sanitary sewer. If not, include the following note on the CSM, "No Building Which Produces Wastewater Allowed on Lot."
- 3). Existing structures on Lot 1 shall meet Town of Beloit setback regulations.
- 4). The Final CSM shall be submitted for review and approval to Agency Staff within one year of Preliminary Approval.

LD 2015 041 (Newark Township) - Leeth

Moved to approve with conditions by Supervisor Gustina, Seconded by Supervisor Davis. Passed (4-0).

Conditions:

- 1). 33' half road right of way dedicated to the public at the discretion of the Town of Newark along S. Smythe School Rd & W. Gravedale Rd.
- 2). Note on Final Map: "Since Lot 1 contains existing buildings which utilize an existing private sewage system, no soil evaluation was required at the time of this survey. However, soils on the lot may be restrictive to the replacement of the system.
- 3). Indicate septic and well locations on Final Map for proposed Lot 1.
- 4). All structures shall meet setback regulations.
- 5). Indicate Wetland Boundary on Final CSM.
- 6). Note on Final CSM for proposed Lot 2, "No building which produces wastwater allowed on lot."
- 7). The Final CSM shall be submitted for review and approval to Agency Staff within one year of Preliminary Approval.
