- 1). Dedicate a 40" ½ Road Right of Way to the town of Johnstown.
- 2). Note on Final CSM: "Lot contains existing buildings that utilize an existing private sewage system at the time of this survey. Since Lot 1 has an existing septic system, no soil evaluation was done at the time of this survey. However, soils on the Lot(s) may be restrictive to the replacement of the system.

- 3). Proposed lot lines shall include the POWTS area with the building that utilizes the system area.
- 4). Final CSM shall be submitted to and approved by the Planning and Development Agency within 1 year of Preliminary Approval.
- 5). Final CSM shall be recorded within 6 months of Final Approval.
