<u>Adoption of Agenda:</u> Motion by Henry Stockwell to adopt the agenda, **Seconded** by Francette Hamilton. Motion approved 6-0

<u>Reading and Approval of the Minutes – September 16th, 2015:</u> Motion by Francette Hamilton to approve the minutes, **Seconded** by Henry Stockwell. Minutes approved 4-0.

Reading and Approval of the Findings of Fact – September 16th, 2015: Motion by Francette Hamilton to approve the Findings of Fact. Seconded by Henry Stockwell. Approved 4-0.

Announcements of Decisions – September 16th, 2015:

Decision of Mathew Fleming et.al. appeal at the September Board of Adjustment read by Chair Jones that the appeal was upheld with a vote of (3-1).

Jerry and Sabrina Elsen Application Case

The public hearing was opened at 6:07 pm.

Exhibit #1 (PowerPoint presentation) provided by applicants was viewed by the board. Mr. Elsen provided commentary, discussion followed.

Mr. Stokes spoke in favor of the applicants.

Exhibit #2 (Mr. Mark Roberts) letter supporting the applicants was read out loud to the Board by Mr. Wheeler.

Exhibit #3 (Gregory and Lisa Seymour) letter in opposition to the applicants was read out loud to the Board by Mr. Wheeler.

Pete Jones spoke in favor of the applicants.

Exhibit #4 (map, pg. 15, Building Design Site Plan Rear View) was presented by Director Byrnes, Discussion followed.

The three Board of Adjustment criteria were discussed as it applied to this application.

The Planning and Development Staff Report was read by Director Byrnes.

Discussion followed, Harry O'Leary made a motion to approve the variance with the following conditions,

- 1). Impervious surface on the lot be reduced to 30%.
- 2). Roof height on a structures limited to 35 ft. Maximum.
- 3). Lots to be combined via a CSM.
- 4). Shoreland (Park Area) vegetation to be restored via a plan submitted by applicant and approved by the Rock County Planning and Development Agency.

Seconded by JP Lengiak. Roll call vote: Tied.

Discussion followed.

Harry O'Leary made a new motion to approve the variance with the following conditions:

- 1). Impervious surface on the lot be reduced to 30%.
- 2). Roof height on a structures limited to 35 ft. Maximum.
- 3). Lots to be combined via a CSM.
- 4). Shoreland (Park Area) vegetation to be restored via a plan submitted by applicant and approved by the Rock County Planning and Development Agency.
- 5). Reduction in total square footage of structure from 2400 sq. ft. to 2200 sq. ft.

Seconded by JP Lengjak. Roll call vote: Approval was Unanimous.

Unfinished Business: None.

New Business: None.

Motion to Adjourn made by Harry O'Leary, **Seconded** by JP Lengjak. All in Favor. **Time:** 7:37 p.m.

After the meeting was adjourned, it was discovered that the Alternate Member J.P. Lengjak was not authorized to vote under the rules of the Rock County Board of Adjustment, as Mr. Lengjak was an *alternate* member of the Board. An additional meeting is scheduled for Wednesday, November 4, 2015 to review and correct this procedural issue.
