12.H. <u>Guidelines and Review Procedures on the Upcoming 5th Step Grievance</u>

Corporation Counsel, Jeff Kuglitsch, presented to the Board regarding a 5th Step Grievance that will be coming before the County Board at their February 26, 2015 general meeting and noted it will likely take place in open session. He explained to the Board that Act 10 created section 66.0509(1m) stats and requires the County to establish a grievance system. Under the new law, only three (3) things are grievable: Termination, Discipline or Workplace Safety.

The Statutes state that "An appeal process in which the highest level of appeal is the governing body of the local government unit" and therefore, the County Board acts as our final decision maker. The steps of grievance procedures under the new law are: Supervisor, Department Head, Human Resources Director, Independent Hearing Officer (IHO) and County Board. The grievance at hand is the first 5th step grievance to come before the County Board and has some general rules as set forth in the Rock County Ordinance Ch. 18, Section 8 Grievance Procedure.

All County Board Supervisors were provided with the Rock County Ordinance Ch. 18, Section 8 Grievance Procedure, the Decision of the Impartial Hearing Officer and the Written Notice of Appeal. The Board was told it has two weeks to read the document and also review the transcripts and attachments that are available in the County Clerk's office and should be prepared to make a decision on February 26, 2015.

The County Board Chair will preside over the 5th Step Grievance. The County Board as a whole serves as the "jury" and the decision must be by majority vote of those present at the appeal. Each side will have 20 minutes as determined by the County Board Chair. The Appealing party goes first, then the responding party, and then rebuttal is allowed if either party reserved such time in their 20 minutes. Nick will keep two separate time clocks for each party. Once the parties have presented, the County Board will deliberate in executive session (parties will be excluded from those deliberations).

The County Board's consideration of appeal will be limited to:

- Review of the IHO's written decision
- The Appealing Party's reasons why the decision is wrong
- The response by the other party along with oral presentations made by the parties.

 Additional information allowed ONLY by the County Board Chair, if relevant and neither party was aware of or could have been expected to be aware of prior to the IHO's decision.

The decision shall not be overturned unless the Board finds by a majority vote:

- The hearing was not conducted fairly
- There was fraud or corruption on the part of the hearing officer, or
- The hearing officer made an error in fact or law The County Board has these options:
- Sustain the Independent Hearing Officer's decision
- Render a new decision
- Any other action the County Board believes is appropriate

A written order will be prepared by the County Board Chair and a copy will be delivered to the grievant within 10 days following the County Board's decision. This is the FINAL administrative appeal.
