Moved by Supervisor Mawhinney with Conditions, Seconded by Supervisor Gustina.

After discussion, the Motion was amended by Supervisor Mawhinney to allow the removal of the driveway servicing E. CTH A to be completed by June 1<sup>st</sup> 2019,(Agency Recommendation #7) and that the existing northern lot be made code compliant regarding vision triangles, and associated vegetation.
