#### Call to Order

#### Approval of the Agenda

#### **Community Agency Updates**

Schools start September 5<sup>th</sup>.

The initial budget has been sent to the County Administrator. There are a number of new positions for CCS in the budget. There is a proposal for a new Operations Manager to oversee the trauma grant and the larger system piece of the CST program.

September 20<sup>th</sup> is a state-level meeting for CST/CCS workers.

#### Wellness & Recovery Empowerment Project (WREP) -

The brochure is almost finalized. WREP will participate in the Latino Community Fair discussion on September 30<sup>th</sup> at Old Brother Dutton School in Beloit. They're discussing a potential health fair in 2018. FB page is updated.

#### Review BHRSC Mission, Goals & Steps -

Tera gave an overview of how the CST/CCOP Committee reports back to the BHRSC. Tera will create some action steps for us to be able to reach our identified goals and will present them to this committee next month. Some suggestions include: increase parental voice and communications at all levels (IEP, roundtables, day-to-day planning, etc.), outreach at community events, create a FB page and brochure for general information, have a sign-up sheet at the CCS picnic for those interested in a parent support group, and coordinate with the community health improvement plan.

## **CCOP Procedure Guide review**

CCOP replaces the family support program and is funding for children that meet the level of care requirements for CLTS. Children who are eligible to receive CLTS services are also eligible to receive CCOP funding. CCOP funding is the most flexible source available for children and can fund services that can't be funded in any other way. CCOP is more family focused for a full wrap-around approach.
