# FINANCE COMMITTEE Minutes – May 16, 2013

<u>Call to Order</u>. Chair Mawhinney called the meeting of the Finance Committee to order at 7:30 A.M. on Thursday, May 16, 2013, in Conference Room N-1 Rock County Courthouse Fast.
