5. ROCK COUNTY TRANSITION TO FAMILY CARE

- There are only 20 currently served individuals to enroll yet with Family Care.
- The State has agreed to have the group of CESA 2 VOA non-waiver clients, who had lost their funding, enrolled in Family Care with a September 1st start date.
- There was a conference call this morning with the MCO's and IRIS to discuss communication between the MCO's and the providers.
- We have been working closely with the Social Security Administration and Good Works Payee Services, Inc. in the transition of Representative Payee duties.

DIRECTOR'S REPORT ON PROGRAM ACTIVITIES

1. Department Updates:

- The Dept. has been working closely with County Administration and the Human Services Dept. regarding the transition of some of the remaining duties of the DD Board such as the contracts with WARC/Guardian Friends and CESA 2 Birth to Three Program.
- The ADRC has been contacting those individuals yet to enroll in Family Care and explaining the need to enroll for transition on September 1st rollout and that failure to do so will result in loss of services on October 1st.

2. Budget Updates:

• The Dept. continues to manage the funds of the individuals the DD Board is still Representative Payee for until a new Payee is designated by the Social Security administration.

3. Residential Placements:

• We are not doing any residential placements now that the transition to Family Care is underway.

4. Consumer Updates:

5. Providers' Concerns:

- The CESA 2 Birth to Three Program will remain with the DD Board through the end of CY2016. The County will work with the State to get the contract moved to the Human Services Dept. for the CY2017 Budget.
- We are working closely with Providers to assure the transition to Family Care goes smoothly. No significant concerns have arisen thus far.
