#### **UNFINISHED BUSINESS**

- 1. Ongoing Review/Update of CY16 Proposed Budget:
  - The CY16 Budget was approved by the County Board.
- 2. Assembly Bill 453 Family Care Option for Rock County:
  - The bill was passed 16-0 by the Finance Committee and has been now is sent to the House for approval, next meeting January 12, 2016.

### **NEW BUSINESS**

- 1. BILLS
  - Bills in the amount of \$306,349.35 were approved on a Motion by Phil Owens, Seconded by Nancy Lannert. Motion Carried.
- 2. APPROVAL OF CONTRACTS/ADDENDUMS

A Motion was made by Lynda Olson, Seconded by Ed Brandsey to approve the following Addendums: Independent Disabilities Services decrease line item #62604 (CIP 1B) from \$304,100 to \$229,100 (-\$75,000). This change is due to an analysis of the first three quarters of the year in an attempt to bring the budget in line with actual costs. Additionally decrease line item #62601 (Purchase of Care) from \$43,000 to \$32,487 (-\$10,533). This change is due to the discontinuation of children's respite services effective September 1. 2015. Northwoods Inc. of Wisconsin increase line item #62604 (CIP 1B) from \$7,772 to \$8,281 (+\$509). This change is due to one client needing additional services. Opportunities. Inc. increase line item #62604 (CIP 1B) from \$112,000 to \$141,372 (+29,372). This change is due to multiple clients needing additional services. PALS Pinnacle Assisted Living Services, LLC decrease line item #62620 (CIP 1A) from \$198,391 to \$0 (-\$198,391) and increase line item #62604 (CIP 1B) by \$198,391 (+198,391). This change is due to one residential client moving from CIP 1A funding to CIP 1B funding. REM WI, Inc. decrease line item #62627 (CIP II) from \$262,296 to \$183,158 (-\$79,138). This change is due to the death of one client. REM Wisconsin II, Inc. decrease line item #62620 (CIP 1A) from \$1,041,332 to \$999,332 (-\$42,000). This change is due to the death of one client and two new clients moving into residential services at a lower rate. Motion Carried.
