1. Department Updates:

2. Budget Updates:

 After considerable discussion and deliberation with Josh Smith, County Administrator, the department made some reductions in our requested amounts in the Emergency/Unanticipated funding areas for CY15. The rationale for doing this was to prevent any of our Providers from having to reduce their budgets from the CY14 level.

- We will be relocating another individual from Bethesda, which is closing its ICFMR unit by a directive of the State, to Clearview in Watertown by the end of the month. This woman has resided at Bethesda for many years and requires a SNF due to her complex medical needs.
