Executive Summary

Authorizing Temporary Double-fill of Substitute Care Supervisor

This resolution authorizes the Human Services Department to temporarily double-fill a Child Protective Services Substitute Care Supervisor position who has worked for the Department for 28 years and is retiring as of February 28, 2021. The double-fill would significantly assist in meeting the training needs of a new supervisor. This supervisor performs many unique tasks that other supervisors do not perform and has years of systemic knowledge to relay to a new person. This position has a primary lead in the CPS area for out-of-home care administrative codes and family find connections. This would be temporary double-fill from approximately 1/25/21 through 2/28/21. There is adequate funding in the CPS personnel budget to cover the increased cost.
