## Awarding Contract for Catering Services for Rock County Elderly Nutrition Program

### **Budget Review.**

(Supervisor Zajac left at 4:30 P.M.)

Council on Aging Ms. Lubben reviewed the highlights of the Department's 2015 Budget as recommended by the County Administrator; 1) eliminate the Volunteer Driver Program due to a decline and the duplication of services offered within the County and that \$600 be provided to RSVP in the Community Services account to support its ride program; 2) an additional 0.40 FTE clerical worker which is funded from federal grant monies with no impact on the tax levy.

<u>Heritage Rock County</u> Mr. Osborne said the agency requested a 3% increase from the prior year, due to a small increase in the 2014 budget and the current budget constraints, the recommendation will remain at the same level of funding as 2014.

**Retired Senior Volunteer Program** Mr. Osborne stated the request for 2015 was the same amount as 2014.

<u>UW-Rock County</u> Mr. Terronez said this falls under the General Services budget and reviewed highlights.

<u>Veterans Service Office</u> Mr. Solis reviewed highlights from the County Administrator's recommended 2015 budget and said his staff must acquire accreditation and take continuing education training courses to gain access to the Veterans Administration computer system. Mr. Solis' budget has an increase of 6% from the prior year due primarily to increases in training and health insurance costs as a result of staff turnover.

### Committee Requests and Motions.

Discussion on Future Meeting Site Visits None.

<u>Ideas for Future Discussion</u> Supervisor Schulz asked Ms. Lubben and Mr. Solis questions regarding the type of services available to disabled vets in the community. The response to her questions would be addressed through the ADRC.

<u>Adjournment.</u> Supervisor Schulz moved adjournment at 4:55 P.M., second by Supervisor Pleasant. ADOPTED.
