Old Business:

- 1. Medical Transportation TCC continues to organize sub-committee for Survey in regards to medical transportation.
- 2. TCC Plan updates None. McIlhone requested any 2020 activities completed by TCC members that would meet the HSTP, to document and e-mail to her.
- TCC 16th Member Update appointments recommended by the TCC, will go to the County board on December 17th, 2020 for review/approval.

New Business:

Jones – Explained the Survey Needs Assessment utilized by Community Action within an access database. Member Reports:

- 1. Jones noted that the Forward Service Corporation provides funds for car loan and vehicle repair.
- Hansberry RSVP increase in numbers, continue to provide PPE's (hand sanitizer, etc.) in response to CV-19. Pantry delivery continues to provide service successfully with appreciative participants. New Portal provided with face to face computer communication.
- 3. Ryan Schomber Rock County Job Center closed to the public, services continue: DVR/DWD. New program out of Janesville. Department of Labor, helps families with opioid addiction via training, career supportive services, etc.
- 4. Schutt in 2021 all Rock County Transit drivers will be Rock County Employees as there were no Bids were received for driver management as in previous years/Bids.
- 5. Thompson Beloit Transit has their new routes in service as of Oct. 20, 2020. Service is going well and the major success being that they are getting more people to jobs.
- 6. Tremain Working remotely and very busy (ADRC), taking many calls. Alexa project continues.
- 7. Brown- is busy, MPO is approaching the long range Transportation Plan/ ADA surveys throughout Janesville.
