SIGNIFICANT CONTRIBUTIONS TO ROCK COUNTY AND ITS PEOPLE:

VOLUNTEER: It is with my greatest pleasure to nominate William Wartmann to the Rock County Hall of Honor for 2016. In 1966 Bill moved from Madison to an abandoned 12-room farmhouse west of Edgerton, in the Town of Porter. While many of his neighbors saw the house only as a wreck; Bill saw its potential. He took it apart and started restoring it. He considered it a labor of love; a 30-year labor of love.

When he married Joyce in 1973 they lived in their home on the prairie and enjoyed their rural life and the people they came to know. They together decided not to spend their money lavishly on themselves but would give it away for public good. That philanthropic decision benefited many people and organizations in our region over the decades.

Mr. and Mrs. Wartmann not only donated to present needs but have provided endowments which will provide security for the future for many organizations. Attached to this nomination form are several letters from organizations which can eloquently explain what Bill means to their organization and the difference he has made.

Above all, Bill is a philanthropist, artist, and educator. The generosity and presence of Mr. and Mrs. Wartmann in Rock County and surrounding areas is hard to articulate in words. Instead, I will quote a few phrases from the letters which impress the impact they have had on our lives.

He also helped create the 'Fourth Ward Committee,' a select group of local residents who have dedicated themselves to bettering the community through improved safety and beatification efforts. He and his fellow Committee members also work closely with local law enforcement and community leaders to deter and prevent criminal activity in the area. He is a tireless advocate for not only building community spirit, but also works to promote safety and instill a renewed sense of community pride.
