 D.Review. Discussion and Adoption of Rules of the Board for 2020-2022.

1) Rule I-I. shall be created as follows:

If, in the opinion of the Chair, a situation arises in which it is in the best interest of the public, the Board, or the County to hold meetings of the Rock County Board of Supervisors by remote electronic audio-visual means, then on a temporary basis, any meeting of the Rock County Board of Supervisors may be conducted by electronic audio visual means. Any electronic meetings must be conducted in accordance with the Wisconsin Open Meetings Law, Wis. Stat. § 19.81, et. seg., such that reasonable notice is provided to the public in accordance therewith, and the meeting is reasonably accessible to members of the public. During any electronic meeting of the County Board, any period normally designated for public hearing or public comment may be omitted, at the sole discretion of the Chair, except those public comment, or public hearing periods, which are required by state law or administrative rule. In lieu of receiving public comments during an electronic meeting, the public shall be made aware of other means by which they may submit their comments, such as email, phone, or U.S. Mail. In order to facilitate the orderly proceeding of business, when necessary as determined at the sole discretion of the Chair, a resolution or ordinance may be brought before the County Board of Supervisors for consideration without report from a governing committee of the County Board as required by Rule IV-D.

Board rule change moved by Supervisors Davis and Mulligan. Supervisors Sweeney and Gustina moved to postpone rule change until there is more detailed language to May 14, 2020 County Board Meeting. Motion to postpone approved by acclamation.

2) Rule IV-P. shall be created as follows:

P. If, in the opinion of the Chair or presiding official of any committee, board or commission of the County Board, a situation arises in which the best interests of the public, the committee, or the County to hold meetings by remote electronic audio-visual means, then the chair or presiding official may hold an electronic meeting consistent with the requirements of Rule I–I.

Supervisors Sweeney and Gustina moved to postpone rule change until there is more detailed language to the May 14, 2020, County Board Meeting. Motion to postpone approved by acclamation.

3) Rule V-). Shall be amended as follows:

O. Airport Board

(1) The committee shall be composed of nine members, of which three shall be County Board Supervisors. Six members shall be drawn from the community, and not elected to any county office, or employed by Rock County, and shall have a demonstrated interest or competence in the field of aviation. The terms for the six members shall commence on January 1, 2019, with one third to serve a term of 3 years, one third a term of two years, and one third a term of one year, with subsequent appointments to be a term of three years, except that any person appointed to fill a vacant position shall be appointed for the remainder of the term of the position to which appointed. The six members drawn from the community shall be limited to service of two consecutive full terms of three years, after which, membersdrawn from the community may serve additional terms under the preceding limitationafter absence from the board for not less than one year.

Board rule change moved by Sweeney and Fox.

Supervisors Rashkin and Davis moved to amend the board rules to add term limits of two consecutive terms to all board committees for citizen members, except as otherwise allowed by statutes effective this point in time forward. Amended board rule change FAILED on the following roll call vote: Supervisors Aegerter, Brien, Davis, Leavy, Lokrantz, Potter, Rashkin, Rynes, Schulz, Taylor, Wilde, Zajac and Purviance voted in favor. Supervisors Beaver, Bomkamp, Pam Bostwick, Rich Bostwick, Fox, Gustina, Homan, Knudson, Mawhinney, Mulligan, Peer, Podzilni, Richard, Sweeney, Williams and Yeomans voted against. AYES – 13. NOES – 16. ABSENT – 0.

Motion on the original board rule to remove term limits to airport board citizen members FAILED on the following roll call vote: Supervisor Aegerter, Rich Bostwick, Brien, Fox, Gustina, Homan, Mawhinney, Peer, Podzilni, Richard, Sweeney and Yeomans voted in favor. Supervisors Beaver, Bomkamp, Pam Bostwick, Davis, Leavy, Lokrantz, Mulligan, Potter, Rashkin, Rynes, Schulz, Taylor, Wilde, Williams, Zajac and Purviance voted against. Supervisor Knudson was absent. AYES – 12. NOES – 16. ABSENT- 1.

4) Rule IV-N, is amended as follows: A majority of committee members will determine the day and time that the committee will meet. <u>However, in no event shall a</u> <u>committee's regularly scheduled meetings occur before 4:30 p.m.</u> Motion to change rule moved by Supervisor Rynes and Taylor. Supervisors Richard and Sweeney moved to postpone to date uncertain. Motion to postpone FAILED on the following roll call vote: Supervisor Beaver, Fox, Gustina, Mawhinney, Mulligan, Peer, Podzilni, Richard, Sweeney, and Yeomans voted in favor. Supervisors Aegerter, Bomkamp, Pam Bostwick, Rich Bostwick, Brien, Davis, Homan, Leavy, Lokrantz, Potter, Rashkin, Rynes, Schulz, Taylor, Wilde, Williams, Zajac and Purviance voted against. Supervisor Knudson was absent. AYES – 10; NOES – 18. ABSENT - 1.

Supervisors Lokrantz and Rynes moved to amend the proposed change to only apply committees under Rule V.

Amended change in Rule IV-N: A majority of committee members will determine the day and time that the committee will meet. <u>However, in no event shall a committee organized under Rule V. have regularly scheduled meetings occur before 4:30 p.m.</u> Amended APPROVED on the following roll call vote. Supervisor Aegerter, Bomkamp, Rich Bostwick, Brien, Davis, Leavy, Lokrantz, Mulligan, Potter, Purviance, Rashkin, Rynes, Schulz, Taylor, Wilde and Williams voted in favor. Supervisor Beaver, Pam Bostwick, Fox, Gustina, Homan, Mawhinney, Peer, Podzilni, Richard, Sweeney, Yeomans and Zajac for against. Supervisor Knudson was absentee. AYES – 16. NOES – 12. ABSENT – 1. The amended rule change FAILED on the following roll call vote. Supervisors Aegerter, Bomkamp, Rich Bostwick, Davis, Lokrantz, Potter, Purviance, Rashkin, Rynes, Schulz, Taylor, Wilde and Williams voted in favor. Supervisors Beaver, Pam Bostwick, Brien, Fox, Gustina, Homan, Mawhinney, Mulligan, Peer, Podzilni, Richard, Sweeney, Yeomans and Zajac voted against. Supervisors Knudson and Leavy were absent. Six members shall be drawn from the community, and not elected to any county office, or employed by Rock County, and shall have a demonstrated interest or competence in the field of aviation. The terms for the six members shall commence on January 1, 2019, with one third to serve a term of 3 years, one third a term of two years, and one third a term of one year, with subsequent appointments to be a term of three years, except that any person appointed to fill a vacant position shall be appointed for the remainder of the term of the position to which appointed.

Motion to change the rule moved by Supervisors Schulz and Rashkin. Motion failed on the following roll call vote. Supervisors Schulz and Zajac voted in favor. Supervisors Aegerter, Beaver, Bomkamp, Pam Bostwick, Rich Bostwick, Brien, Davis, Fox, Gustina, Homan, Leavy, Lokrantz, Mawhinney, Mulligan, Peer, Podzilni, Potter, Rashkin, Rynes, Sweeney, Taylor, Wilde, Williams, Yeomans and Purviance voted against. RE: Sales Tax-Funded Capital Project Reductions

At a previous County Board meeting I briefly mentioned estimates of reductions in sales tax receipts that we may experience in 2020 due to COVID-19. This memo includes my more detailed recommendations on which projects we should pause in 2020 to reconcile expected receipts with expenditures.

An analysis conducted by the Wisconsin Counties Association's Forward Analytics unit completed in March 2020 forecast a reduction in sales tax collections for Rock County of 11.6% if the Safer at Home order was extended through May, which has occurred. Regardless of the future of any State orders, it seems likely at this point that local retail purchases will continue to depressed beyond the level anticipated in March. Therefore, I am currently recommending that we suspend sales tax-funded capital projects totaling \$2,215,904. This represents a 15.1% reduction to the \$14,656,404 in sales tax collections that were budgeted in 2020.

The attached spreadsheet lists these project in three categories, as described below.

Savings from Completed Projects

Several sales tax-funded projects or purchases have already been completed this year. The net savings from these projects is \$32,654. I would note that three of these projects were over budget. The overage for the Courtroom H Sound System project will have to be made up from other savings in the Facilities Management budget. Slight overages for the Airport garage project and the Sheriff's airboat purchase will be made up through reductions in other sales tax purchases in those departments.

Savings from Suspended Projects

I am recommending that we suspend or otherwise recover funding from 9 projects at this point for a total savings of \$2,183,250. Projects and brief rationale are as follows:

- 1) District Attorney's Office renovation—I am recommending we continue with the design and bidding of this project at a cost of \$101,914. This will allow us to move quickly into construction in 2021 and to take advantage of 2020 prices by completing the bidding this year. Savings will total \$973,086.
- 2) Public Works CTH F Reconstruction (Stone Farm Road to Indianford)—I am recommending we spend about \$103,000 of the \$853,000 budgeted for this leg of the project to conduct grading and other site work to prepare this portion of the project to be paved quickly in 2021. This will result in a savings of about \$750,000. I would note that we will continue with the much larger portion of the CTH reconstruction from Highway 14 to Stone Farm Road. We also felt that reducing the scope of the CTH F project this year would reduce risk related to the uncertainty of the effect of COVID-19 on the DPW workforce.
- 3) Airport Runway 18/36 Resurfacing—We are receiving approximately \$157,000 in additional federal airport aid, which I am recommending replace the sales tax funding of \$150,000 that was to be used for this project.
- 4) Public Works CTH O Design—This project is not planned for construction until 2022, so the \$120,000 in design costs can be completed in 2021.
- 5) Land Records Elevation Flyover Project—We ended up receiving a state grant to cover the \$87,000 cost of this project.
- 6) Public Works Parks Sweet-Allyn Playground Replacement—While this may actually be the best time to replace the playground, when children are not using it, this is not an essential purchase that needs to be completed in 2020. Savings total \$50,000.
- 7) Sheriff's Office Bluetooth Extenders—The Sheriff's Office has determined not to move forward with this project in 2020 as they look for a different solution. Savings total \$35,052.
- 8) Airport Repair of Southeast Ramp Lights—This project was folded into another project where there was savings at the end of 2019. Savings totals \$20,000.
- 9) Airport Additional Funds for Broom Truck—An additional \$3,000 was needed to add to funds already available from prior years to replace the Airport's broom truck. However, it was already decided that this purchase will not be made in 2020. Additional funds for this purchase may have to be provided in the 2021 budget.

The attached spreadsheet also includes sales tax-funded projects and expenditures that I am recommending we continue to move forward with this year. These recommend maintenance projects that if delayed would result in increased costs, critical information technology and 911 infrastructure, construction projects, and other priority purchases.

I will be available to answer questions at your meeting on May 14.

Executive Summary

The Information Technology Department included funds in the 2020 budget for a project to refresh the County's network equipment. This project will update all of the Cisco switches in the entire County including Public Safety, the Courthouse, Human Services Department, and outlying areas. The switches and software would allow for the IT Services staff to configure the software to identify anomalies as well as other monitoring tools that must be administered on a one to one manual basis. Additionally, this project would allow for the mass migration of departments to new buildings such as the 1717 Center Avenue project that will be occurring in 2021.

In addition, this purchase will include Cisco's Identify Services Engine (ISE) software which aids in network policy enforcement. This is a giant step in improving the security of the network.

This equipment and software will modernize the County infrastructure which will lead to a more reliable and secure network. It will also allow for more efficient means of maintaining and updating network components.

The equipment and software are available from CoreBTS, Inc. under state Contract: #505ENT-M16-DATACOMMUN-01.

The request for funds for this purchase were included in the 2020 Rock County budget.

AUTHORIZING APPLICATION WITH WISCONSIN DEPARTMENT OF NATURAL RESOURCES FOR STEWARDSHIP, LOCAL ASSISTANCE, FEDERAL LAND & WATER CONSERVATION FUND, & RECREATIONAL TRAILS PROGRAM APPLICATION GRANT FUNDS

We are in the final stages of adopting the 2020-2025 Rock County Parks Outdoor Recreation and Open Space (POROS) Plan. The 2020-2025 Rock County POROS plans recommends paving the Peace Trail from Janesville to Beloit with a hard surface to improve accessibility. This resolution provides authorization to apply for funding from the Wisconsin Department of Natural Resources for Stewardship, Local Assistance, Federal Land & Water Conservation Fund, and Recreation Trails Program Application Grant Funds and include the City of Janesville's portion.

In order to move forward on this project, the Rock County Parks Division desires to apply for Department of Natural Resources Recreational Trails Stewardship Grant Fund and be the project sponsor for the City of Janesville's portion of the Peace Trail. This grant program prioritizes projects that rehabilitate existing trails and inter-governmental cooperation.

The grant being applied for requires a 50/50 match of local funds. The anticipated joint project cost for the paving of the Peace Trail is \$423,200, of which \$211,600 would be covered by the Stewardship Grant funds. Rock County's share of the project costs would be \$139,750, with the City of Janesville contributing \$71,850.

The Stewardship Grant is open for applications on an annual basis. In an effort to maximize grant opportunities, we are requesting approval to submit this application in the 2020 cycle. With a determination of approval anticipated during the summer/fall of 2020, the Parks Division would be able to pursue completing this project as early as 2021.

If the grant application is approved, the County would have until June 30, 2023, to utilize the funds. Currently, the Parks Division is pursuing additional funding options, including possible donations or use of ATC funds, to offset the remaining balance not covered by the Stewardship Grant. The Parks Division does not intend to impact current or future County fund balances with this grant application. If the grant is approved, further action from the County Board would be required to accept the Stewardship Grant funding and authorize paving of the Peace Trail.

If the grant application is not approved, the Parks Division will delay the project and look to pursue a grant opportunity in the 2021 cycle.

WHEREAS, on March 24, 2020, the Wisconsin Department of Health Services issued Emergency Order #12 "Safer at Home" to slow the spread of the Novel Coronavirus by ordering all Wisconsin Residents to stay at their current residence unless they needed to use or provide essential business and services until April 24, 2020; and

WHEREAS, on April 16, 2020, the State's Safer at Home order was extended until May 26, 2020; and

WHEREAS, Governor Tony Evers established the Badger Bounce Back Plan on April 20, 2020, as a
 framework to the re-opening of Wisconsin businesses, and an integral part of the plan includes an increase
 in testing lab capacity and an increase in contact tracing to track the spread of COVID-19; and

WHEREAS, the Badger Bounce Back plan emphasizes that testing without tracing will not result in controlling the spread of the virus and Wisconsin has identified a need to increase the number of contract tracers in the state; and

WHEREAS, the Rock County Public Health Department currently conducts contact tracing and case
 investigation for all positive test results of residents of Rock County; and

WHEREAS, the Public Health Department has 10.0 FTE in Public Health Nurses and is using
Environmental Health Specialists to provide additional support for contract tracing; and

22 WHEREAS, the County has been able to re-deploy some additional staff to support contact tracing; and

WHEREAS, the Public Health Department has been able to hire temporary Public Health Nurses to
 support contact tracing and case investigation; and

WHEREAS, these resources may not be sufficient to conduct all of the contact tracing and case investigation of COVID-19 patients in the most timely manner possible; and

WHEREAS, it is the best interest of Rock County, its residents, and its workforce to increase the number
 of contact tracers available; and

Executive Summary

The COVID-19 global pandemic has infected residents and has spread within Rock County. Wisconsin has been under a Safer-at-home order since March 24, 2020 intended to slow the spread of this new virus. Safer at home has saved lives, protected health care workers and critical employees, and prevented our hospitals from being overrun, but we know this is not a long term workable solution for the economy. Wisconsin has created the Badger Bounce Back plan to re-open the state in the safest way possible.

The Badger Bounce Back Plan emphasizes three core responsibilities of testing, tracing, and tracking the spread of COVID-19. The state has ramped up testing with a goal of approximately 12,000 tests a day. However, testing without contact tracing will not result in controlling the spread of COVID-19. Wisconsin, and Rock County, need to increase contact tracing efforts to make sure that everyone is contacted and have what they need to safely isolate and quarantine.

The Rock County Public Health Department has exhausted the capacity of their current staff. While we have been able to hire some temporary limited term Public Health Nurses, the need for contract tracing still exists.

This resolution would create a new position of Public Health Contact Tracer and place it in range 13 of the Unilateral Pay Grid. The Human Resources Department will work with Public Health to recruit and hire project Public Health Contract Tracer positions.

LEGAL NOTE:

The County Board is authorized to take this action pursuant to secs. 59.01 & 59.51, Wis. Stats. However, adoption of this resolution will not legally compel disclosure of information to local government agencies, or the dismissal of the public health officer if such disclosure were to not occur.

HIPAA places the discretion to release Protected Health Information ("PHI") with the health professional who is in custody of that information. Protected Health Information can include information that does not disclose the name of a patient. For instance, a patient's residential address, phone number, birth date, social security number, and even the dates of medical procedures or diagnostics can be considered PHI even when released without the name of the patient. Pursuant to HIPAA's Privacy Rule, PHI may not be disclosed by a health professional without the informed consent of a patient, unless the disclosure meets one of the enumerated exceptions to the requirement for informed consent. HIPAA does allow for the disclosure of PHI without informed consent of the patient when the disclosure is necessary to prevent or lessen a serious and imminent threat to the health and safety of a person or the public. Any information shared under this exception to needing informed consent must be limited to only the minimum information necessary to satisfy the particular purpose for which the information is being shared. HIPAA delegates the decision whether an exception is met, and to what extent disclosing information meets the minimum necessary standard to the health professional who is custody of the information. Neither the Rock County Board of Supervisors, nor the County Administrator, has the legal authority to substitute its judgment for that of Public Health Officer's and compel the Public Officer to disclose PHI.

Additionally, because the Board does not supervise the public health officer the Board does not have the power to remove the public health officer. Department heads are appointed and supervised by the County Administrator. See Wis. Stat. § 59.14(2)(c). While a department head's appointment must be confirmed by the County Board, the department head serves at the pleasure of the county administrator and the County Board does not have any supervisory authority over the department head. *Id.* (" Any department head appointed by a county administrator under this paragraph may be removed at the pleasure of the county administrator.") The legislature has vested the removal power solely in the county administrator.

Accordingly, if the County Board of Supervisors were to adopt this resolution, it would be in an advisory capacity only.

ADMINISTRATIVE NOTE:

The Federal Office of Civil Rights in the Department of Health and Human Services, Governor Evers, Attorney General Kaul, the Wisconsin Counties Association, and every other county in Wisconsin have determined that compliance with the "imminent threat" and "minimum necessary" provisions of HIPAA means that addresses of individuals with COVID-positive tests are to be shared only with 911 dispatch, which will then share this information with first responders on a per-call basis only. Specifically:

The Office of Civil Rights provides a directly applicable example in its COVID-19 guidance:

"A covered entity [NOTE: such as the Rock County Public Health Department]...may provide a list of the names and addresses of all individuals it knows to have tested positive, or received treatment, for COVID-19 to an EMS dispatch for use on a per-call basis... A covered entity under this example also should not distribute compiled lists of individuals to EMS personnel, and instead should disclose only an individual's information on a per-call basis."

The Governor's Emergency Order #19 directed all counties to share addresses of individuals with COVID-positive tests with dispatch centers (I would note the Rock County Public Health Department began sharing this information with the 911 Center before the Governor's Order). The Attorney General provided guidance to accompany this Order, which read in part:

"No agencies or individuals outside of a designated dispatch center are to maintain or distribute the information obtained in conjunction with this order. This includes but not limited to daily logs, shift briefings, "BOLOS", "Hotsheets," etc."

The Wisconsin Counties Association (WCA) and its general counsel, von Briesen & Roper, provided further guidance to counties on this issue as follows:

"The Governor's Emergency Order #19 requires local health officers to report to **dispatch centers** (not directly to law enforcement or first responders) any known positive COVID-19 cases within the dispatch center's jurisdiction.... Guidance from federal agencies and Emergency Order #19 both contemplate that disclosures relating to COVID-19 be made to dispatch centers and then from the dispatch center on a per-call basis to first responders actually making contact pursuant to a dispatch call."

After speaking with the WCA and my colleagues in other counties, I am not aware of any county in the State of Wisconsin that is providing addresses of individuals who have tested positive for COVID-19 to other municipalities in the way this resolution requests. While some municipal fire/EMS agencies statewide may possess the addresses of individuals who have tested positive, it is only because those fire departments operate their own dispatch centers, which under the Governor's Order are to receive these addresses (not all counties have a countywide 911 dispatch center, nor do all counties have a countywide health department like Rock County). However, in places like Jefferson and Walworth counties where this is the case, the counties have entered into MOUs with the municipal dispatch centers to indicate that these addresses are to be used by dispatch on a per-call basis only and not shared as lists with first responders or others.

With regard to information sharing more generally, the Health Officer and I have noted from the beginning that as the number of cases increases (and consequently the likelihood of identifying any individual patient decreases), the Health Department will be able to share more information in aggregate, and it has done so. The Rock County website now includes cases by zip code, census tract, age group, gender, race, and ethnicity, as well as the number of negative, probable, and recovered cases. The Health Department has recently worked with local businesses and long-term care facilities where positive cases have occurred to self-identify through joint press releases with the Health Department. Further, the recent increase in testing has resulted in a spike in positive cases, confirming the message we have been sharing all along: we all must assume that everyone in the community has been exposed to COVID-19 and take necessary precautions; it is speculated that half of all people with COVID-19 show no symptoms.

While both the Health Officer and I would acknowledge that the County's response has not been perfect due to the significant learning curve for us all, Rock County has taken actions consistent with state and federal directives and the actions of other counties throughout the state. In this context, relieving the Health Officer of her duties in the middle of the biggest public health emergency any of us will likely ever face would be detrimental to our ongoing response and to the health and safety of County residents.

HIPPA states, the information can be released, when the disclosure of Protected Health Information to first responders is necessary to prevent or lesson a serious and imminent threat to the health and safety of a person or the public. Information is not being relayed to agencies for the prevention of the spread of COVID-19. Agencies and/or first responders are not getting follow up or notification from the Health Department after being exposed to the virus. The Health Department has a list of known addresses that have a positive case. This information is already given to the 911 center.

AMENDING COUNTY BOARD RULES I & IV

NOW, THEREFORE, BE IT RESOLVED that the Rock County Board of Supervisors duly assembled this day of May, 2020 hereby amends the Rules of Procedure of the Rock County Board of Supervisors as follows:

(1)Rule I-I. shall be created as follows:

If, an emergency situation arises, in which in the opinion of the Chair and Vice Chair 7 I. collectively, it would be unsafe, or a threat to the health of members of the Board of Supervisors, or 8 members of the public, to hold an in-person meeting, then on a temporary basis, any meeting of the Rock 9 County Board of Supervisors may be conducted by electronic audio-visual means. Any electronic 10 meetings must be conducted in accordance with the Wisconsin Open Meetings Law, Wis. Stat. § 19.81, et. 11 seq., such that reasonable notice is provided to the public in accordance therewith, and the meeting is 12 reasonably accessible to members of the public. During any electronic meeting of the County Board, any 13 period normally designated for public hearing or public comment may be omitted, at the sole discretion of 14 the Chair, except those public comment, or public hearing periods, which are required by state law or 15 administrative rule. In lieu of receiving public comments during an electronic meeting, the public shall be 16 17 made aware of other means by which they may submit their comments, such as email, phone, or U.S. Mail. In order to facilitate the orderly proceeding of business, when necessary as determined at the sole discretion 18 of the Chair, a resolution or ordinance may be brought before the County Board of Supervisors for 19 consideration without report from a governing committee of the County Board as required by Rule IV-D. 2.0

WHEREAS, in December, 2019, a novel strain of coronavirus known as COVID-19 was detected, and COVID-19 has continued to spread throughout the world, including to the United States and the State of Wisconsin ("COVID-19 Pandemic"); and

Executive Summary

In response to COVID-19, the Legislature passed and the Governor signed 2020 Act 185. Among other things, Act 185 allows local governments (taxation districts) to waive interest and penalties on property tax installment payments due after April 1, 2020. All property tax payments would be due by October 1, 2020, after which time property tax payments would again be considered delinquent, and interest and penalties would again accrue.

For taxation districts to be able to take advantage of this, counties must first pass a resolution that allows them to do so and sets the conditions. The primary condition the Board must determine is whether to allow local governments to determine hardship—and thus the ability of taxpayers to take advantage of the waiver—on a case-by-case basis or have it generally apply to all taxpayers in their jurisdiction. Due to the administrative challenges, the Wisconsin Counties Association and County staff recommend only allowing local governments to allow hardship to generally apply to all taxpayers in their jurisdiction.

Act 185 also allows the County to decide whether to settle taxes with all the underlying jurisdictions at the regular settlement date in August, or to settle only the portion that has been collected in August and the remainder in September. Moving final settlement to September could create cash flow problems for local governments, and particularly school districts, which would normally receive property tax funding in August. Leaving full settlement in August could create cash flow issues for counties for one month. Due to the administrative challenges of managing two settlement dates, and to maximize the opportunity for local governments and their taxpayers to take advantage of the program, this resolution would continue full settlement in August. The County has sufficient reserves to manage one month of reduced cash flow.

If the County Board passes this resolution, each taxation district would also then need to pass a resolution establishing terms consistent with the County's resolution. Several local governments have expressed an interest in passing such resolutions, but overall participation is unknown at this time. Given the possibility that not all taxation districts in the County will participate, it is possible there will be confusion among taxpayers. Communication will be important to reducing potential confusion.

Executive Summary

Supporting Creation of a Community Task Force on COVID-19 Response, Reopening, and Recovery

Recently, community leaders have been discussing the need to develop and coordinate efforts to continue the County's response to COVID-19, as well as plan for the reopening and recovery steps that will be occurring next.

While COVID-19 remains a significant threat in our County, statewide there is increased movement toward meeting the reopening criteria in the Governor's Badger Bounce Back Plan. In addition, there is uncertainty regarding whether any statewide orders will be extended or abolished.

Given these factors and the ongoing impact COVID-19 will continue to have on the community, a localized approach to planning is needed. Efforts are underway to create a task force of stakeholders from numerous areas of influence and need throughout Rock County to serve in this role.

Passing this resolution would show the County Board's support for these efforts, as well as direct County staff to provide resources in support as agreed upon by the task force participants.
