## 1. Department Updates:

- The Dept. has been working on budget issues and ongoing evaluation of some of our programs.
- The Dept. is sponsoring a training at the Pontiac Center on Tuesday, September 30<sup>th</sup> on "Person-Centered Planning".
- The Dept. participated in our Birth to Three On-Site visit yesterday.

#### 2. Budget Updates:

• The Dept. met with the County Administrator and his team last Friday, September 19<sup>th</sup> to review our Proposed 2015 Budget. The Dept. was asked to provide Administration some additional materials, which has been done.

#### 3. Residential Placements:

 On September 11<sup>th</sup> the Dept. placed an individual back into the community from Central Wisconsin Center. This placement/transition has been in the works for almost a year.

## 4. Consumer Updates:

- Last week we had an individual pass away. This individual was transitioned into the community from one of the State Centers 21 years ago and had since enjoyed a very productive life.
- We currently have several individuals in the hospital that we are monitoring, including one who began receiving Hospice care and is receiving comfort measures due to their critical medical condition.
- We had two individuals move into nursing home care this week. One due to a stroke and one due to a deteriorating medical condition.

#### 5. Providers' Concerns:

- The Birth to Three program had its On-Site visit yesterday from the State. The State was very pleased with many aspects of Rock County's Birth to Three Program such as: Progress in moving to a primary coach model of intervention; Meeting federal indicators; Communication and collaboration between the providers, county and CESA; Transparency of the program.
