Executive Summary

Awarding Contract to B&B Quality Restoration for UW-Rock County Wells Cultural Center Band Room Parapet and Wall Repair

The UW-Rock County Wells Cultural Center Band Room parapet and wall is in need of tuck pointing and cap repair to prevent further deterioration due to water damage and spaulding of the brick.

Rock County went out for bid for the repair and received 4 bids. The high was \$68,650.00 and the low was \$11,380.00.

Rock County Facilities Management Director had some concerns about the large gap between the high and the low and requested the Purchasing Manager contacted the low bidder and high bidder about their pricing.

The low bidder (B&B Quality Restoration) indicated that the plans and specifications were very clear and that he was good with his price. The high bidder (RD Woods) was asked to explain his bid being 3 times higher than the other bids. They failed to respond to our request.

B&B Quality Restoration completed the HCC building tuck pointing and chimney removal and did quality work. Director of Facilities Management is recommending this resolution to contract with the low bidder, B&B Quality Restoration.
