## **Authorizing Contracts and Expenditures to Support COVID-19 Public Isolation Shelters**

WHEREAS, the COVID-19 global pandemic has created a need for COVID-19 positive and/or exposed citizens to isolate themselves from the general public; and

WHEREAS, certain COVID-19 positive and exposed citizens cannot isolate/quarantine at their residence without compromising the safety of other occupants with certain pre-existing conditions; and

WHEREAS, the State of Wisconsin has provided a Local Community – Isolation Site Operation Manual to assist communities with a blueprint to respond to the public health emergencies that may occur at the state, tribal, county and local levels; and

WHEREAS, the State of Wisconsin Department of Health Services Division of Public Health will reimburse at cost all expenses incurred by a local health department in quarantining a person outside his or her home during the public health state of emergency declared by the Governor in response to the COVID-19 pandemic; and

WHEREAS, Local Public Health Departments should report expenses in the Community Aids Reporting System (CARS); and

**WHEREAS**, the County of Rock has a responsibility, as well as an opportunity, to assist the County's citizens in their isolation efforts to flatten the curve of COVID-19 and the benefit therefrom.

NOW, THEREFORE, BE IT RESOLVED that the Rock County Board of Supervisors, duly assembled this /// day of /// (2020, does hereby authorize a contract with Trienda of Portage, WI for purchase of partitions at a cost of \$44,712.00 (Forty-four Thousand Seven Hundred Twelve Dollars) to set-up 44 ten foot by ten foot units for general public isolation.

**BE IT FURTHER RESOLVED** that the County Board approves purchasing vinyl privacy curtain panels for the front of each of the 44 isolation units at a cost not to exceed \$15,000 (Fifteen Thousand Dollars).

**BE IT FURTHER RESOLVED** that the County Board approve contracting with Best Events of Janesville, WI for catering services to the occupants of the isolation facilities for \$26 (Twenty-six Dollars) per occupant, per day consisting of three meals and two snacks and a delivery fee of \$20 (Twenty Dollars) regardless of the number of meals ordered

**BE IT FURTHER RESOLVED** that the County Board authorizes a contract with Portable Restroom Trailers, LLC of Fond du Lac, WI for an ADA Restroom and Shower Trailer at a cost of \$4,000 per week and a delivery/pick-up fee of \$1,440 (One Thousand Four Hundred Forty Dollars) each way.

BE IT FURTHER RESOLVED that the County Board authorizes a contract with RK Ventures, Inc. of Racine, WI. for a high volume air circulation system, Maxum HEPA Air Purifier and LA2-RC2 Air Purifier filters at a total cost of \$10,950 (Ten Thousand Nine Hundred Fifty Dollars).
