We are seeking your input on proposed bridge replacement project on County E over Marsh Creek in the Town of Janesville in Rock County.

The existing bridge is deteriorating and needs replacement. The following needs have been identified:

- The existing structure was built in 1953
- Superstructure (deck, railing, girders, etc.)
 - Spalling (breaking away)
 - Cracking
 - Exposure of reinforcement steel
 - Heavy deterioration
- Substructure (abutments and wingwalls)
 - Concrete cracking, spalling, and steel corrosion throughout

Proposed improvements will:

- Remove existing structure
- Replace 50-feet of roadway pavement on either side of bridge
- Replace shoulders in areas of new guardrail and grading

- Each abutment has vertical cracks and the wingwalls are moving
- Existing guardrail
 - Not properly connected to the bridge barrier
 - Does not meet current standards for length or crashworthiness
- Existing deck drains
 - Deteriorating and ineffectively draining
 - Install new guardrail
 - Install new deck drains off the structure on the south side of the bridge
 - Install new pavement marking

Right of way acquisitions are not anticipated for this project. Construction is currently scheduled for 2023. The roadway will be closed during construction and traffic will follow a posted detour.
