### Amending DPW Budget to Authorize Renovations to the Shopiere Shed

Mr. Coopman stated that due to the delay of the I90/39 project, he feels an additional \$16,500 is needed for upgrades to the project, and he is confident we would use the site for a minimum of five years. The additional funding would be used for additional paving and grading. This additional work is necessary to handle the traffic and weight of equipment. Once the state builds the I90-39 storage building, this site will be used for dry storage.

Supervisor Fox moved to amend the resolution to increase the funds from \$41,700 to \$58,200, second by Supervisor Podzilni. Motion failed on the following vote: Yes – Supervisors Fox and Podzilni; No- Supervisors Kraft and Mawhinney.
