AUTHORIZING APPLICATION WITH WISCONSIN DEPARTMENT OF NATURAL RESOURCES FOR WARREN KNOWLES-GAYLORD NELSON STEWARDSHIP GRANT FUNDS

WHEREAS, Rock County desires to participate in stewardship grant funded projects pursuant to provisions of s.23.09(11) of the Wisconsin Statutes; and,

WHEREAS, matching grant funds are available from the Wisconsin DNR and a resolution of application for Stewardship Grant Funds is required; and,

WHEREAS, Rock County is interested in developing lands for public outdoor recreation purposes as described in the application; and,

WHEREAS, Rock County Parks has been engaged in the Beloit-Janesville Bicycle Route Corridor Master Plan and Feasibility Study, and has contributed towards the selection of preferred routes from the City of Janesville to the City of Beloit, including routes which pass through Rock County and Town of Beloit-owned lands and rights-of-way; and,

- EXECUTIVE SUMMARY -

AUTHORIZING APPLICATION WITH WISCONSIN DEPARTMENT OF NATURAL RESOURCES FOR WARREN KNOWLES-GAYLORD NELSON STEWARDSHIP GRANT FUNDS

We are in the final stages of finalizing easements for the Beloit to Janesville Trail. One of the focuses of the POROS plan is making the trail system sustainable, including development and maintenance.

In order to move forward on this project, the Parks Division desires to apply for Department of Natural Resources Recreational Trails Stewardship Funds. This grant program prioritizes projects that develop new partnership trails. The project will establish gravel bike trail from Bass Creek Road to Big Hill Park on Duggan Road and Walters Road.

The grant being applied for requires a 50/50 match of local funds. The anticipated project is \$100,000 of which approximately \$50,000 would be Stewardship Funds. The local match would be budgeted in the 2017 Park's Capital Budget with combined funds and volunteer efforts from the Rock Trail Coalition.
