Human Services Ms. Thompson reported the following:

- Information on cases with funding, numbers being served, and waiting list as of 6/23/11.
- COP over budget by \$60,000
- Will be serving (1) Children's Long Term Support (CLTS) clients with COP dollars used as match

Ms. Thompson responded to questions.

Developmental Disabilities As no one from Developmental Disabilities was present at the meeting, Ms. Jensen read through the report included in today's packet.

Old Business:

<u>Long Term Care Reform</u> Ms. Thompson stated that the funding caps for Family Care counties will remain the same. There will be no expansion of Family Care until 2013. Both Kenosha and Racine counties have put in request for proposal and are looking for a new Managed Care Organization (MCO). The Waiver program in Rock County will continue until July 1, 2013.

New Business:

Approval of COP Funding While Institutionalized Ms. Thompson requested approval for four individuals. 1) Jan-Feb \$3,482.16 for care to hold bed at CBRF facility. Ms. Weirich moved approval to fund this request, seconded by Ms. Hubbard. 2) Mar-May \$2,376.66 for care to hold bed at CBRF facility, plus \$35.00 for adaptive aid. Ms. Cavey moved approval to fund this request, seconded by Ms. Patch. 3) May-Jun \$3,037.26 to hold bed at facility. Ms. Hubbard moved approval to fund this request, seconded by Ms. Cavey. 4) \$80:00 for chore services. Ms. Weirich moved approval to fund this request, seconded by Ms. Patch.

<u>Success Stories</u> LTS Case Manager, Joyce Hereford, shared a case story concerning a woman who was able to move out of a nursing home and back into the community, because of the LTS programs available.

Committee Member Comments

Mr. Reich shared his experience while visiting and teaching in Mexico.

Ms. Weirich gave information regarding a "Stepping On" program being offered by the Rock County Council on Aging Department.

Ms. Patch gave information about a program called "Living Well with Chronic Illness"

Ms. Hubbard inquired about appropriate referrals for Long Term Support.
