1. BILLS

• Bills in the amount of \$198,117.76 were approved on a MOTION BY Ed Brandsey, SECONDED BY Becky Heimerl. MOTION CARRIED.

2. APPROVAL OF CONTRACTS/ADDENDUMS,

• A MOTION was made BY Nancy Lannert, SECONDED BY Terry Fell, to approve the following 2013 Purchase of Service Contract Addendums: Cartographics to increase from \$0 to \$9,494 (+9,494) within Line Item #62627 (Brain Trauma)as a result of one current client moving into residential services from home; Epilepsy Foundation of Southern Wisconsin WI to be known as Epilepsy Foundation Heart of Wisconsin, Inc.; Dungarvin Wisconsin, LLC to increase from \$0 to \$21,470 (21,470) within Line Item #62627 (Brain Trauma) as a result of one current client moving into residential services from home; REM Wisconsin II, Inc. to decrease from \$105,143 to \$6,897 (-98,246) within Line Item #62627 (Brain Trauma) as a result of one client moving out of residential services. MOTION CARRIED.

3. ENCUMBRANCES

A MOTION was made BY Nancy Lannert, SECONDED BY Lynda Olson, to approve the following 2013 Pre-Approved Encumbrance Amendments: C.E.S.A. #2 Vocational Program to increase from \$45,900 to \$46,500 (+600) within Line Item #62601 (Purchase of Care) as a result of client losing CIP 1B funding and continuing in the DD Vocational Follow-up Program; Brotoloc South, Inc. to increase from \$0 to \$20,480 (+20,480) within Line Item #62620 (CIP 1A) as a result of one current CIP 1A client moving into residential services; Rehab Resources Inc. to increase from \$132,000 to \$172,000 (+40,000) with in Line Item #62601 (Purchase of Care) as a result of an increased number of children receiving therapy and multiple therapy services in the Birth to Three Program; Alpha Homes of Wisconsin, Inc. to increase from \$573,831 to \$668,110 (+94,279) within Line Item #62604 (CIP 1B) as a result of one current CIP 1B client moving into residential services from another facility and adding additional funding to maintain scheduled day services for two CIP 1B clients; Alpha Homes of Wisconsin, Inc. to increase from \$117,950 to \$128,313 (+10,363) within Line Item #62620 (CIP 1A) as a result of extra care for one current CIP 1A client.
