- 1. Department Updates:
  - We are looking to open up four new clients off the waiting list by Nov 15<sup>th</sup>. Services for these individuals range from case management, respite, day services and recreational. These opening are a result of attrition within the system.
- 2. Budget Updates:
  - Mr. Knutson will present the 2014 Budget to the County Board Supervisors on Thursday, Oct 10<sup>th</sup> at 6 pm at the Board of Supervisors Meeting. The Budget for the DD Board, as presented on Thursday, will be reviewed at the next DD Board meeting on Oct 23<sup>rd</sup>. At that meeting, the Board will need to move to endorse the Budget or move to have the Finance Committee make changes.

  - We currently have 3 openings in our residential programs that we are looking to fill.

  - We have several individuals that are in hospitals for various reasons. Some are not doing very well.
