Mr. Otterstein indicated these would be typically a general or a selective business security agreement, with personal guarantees required from any business owner with more than 20% ownership interest in said business. If and when possible, the intent would be to secure a shared primary vs. secondary (i.e. subordinated) collateral position.

Committee Member Fisher asked if the goal was to loan the entire \$1 Million dollars allocated to the SBLF. Mr. Otterstein indicated that was the intent of the County Board Resolution establishing the loan program.
