Mr. Smith handed out copies of Recommended Revisions to the 2017 Recommended Budget. He said this would be a change to the Human Services budget for a position change to more properly reflect the work being done, and not lose our employees to others for higher pay.

Ms. Luster explained the position and said the title of Human Services Department Analyst would better describe the position. She added that this was approved unanimously by the Human Services Board.

Chair Mawhinney asked if this would change the tax levy. Mr. Smith replied it would not.

Supervisor Kraft moved approval of this recommendation to change the 2017 Recommended Budget, second by Supervisor Fox. ADOPTED.

Discussion on the request at the November 9 County Board meeting from HealthNet for \$25,000 for dental care.
