Authorizing Contract for Justice and Mental Health Consultant

"NOW, THEREFORE, BE IT RESOLVED that the Rock County Board of Supervisors duly assembled this _____ day of _____, 2011 does hereby authorize a contract with Zia Partners and TriWest Group to conduct a full needs and resource assessment regarding mental health and co-occurring disorders as they relate to the criminal and juvenile justice systems in Rock County, as well as assist in the draft of a strategic plan to deal with the aforesaid issues pursuant to the grant application, in an amount not to exceed \$42,500."

Supervisor Wiedenfeld moved approval of the above resolution, second by Supervisor Knudson. ADOPTED.

Adopting the Rock County Hazard Mitigation Plan

"NOW, THEREFORE, BE IT RESOLVED, that the Rock County Board of Supervisors duly assembled this ______ day of ______, 2011, does hereby adopt the Rock County Hazard Mitigation Plan as an element of the Rock County Comprehensive Development Plan.

BE IT FURTHER RESOLVED, that the updated Plan be forwarded to the cities and villages in Rock County for their adoption, thereby making their communities eligible for various hazardous mitigation grant programs.

BE IT FURTHER RESOLVED, that Rock County Emergency Management will submit, on behalf of the participating municipalities, the adopted Rock County Hazard Mitigation Plan to the Wisconsin Emergency Management and Federal Emergency Management Agency for final approval."

Supervisor Knudson moved approval of the above resolution, second by Supervisor Brill. ADOPTED.

<u>2010 Annual Report – Mediation and Family Court Services</u> The Committee had no questions and accepted the report.

<u>Countywide Communications Upgrade – Update.</u> Mr. Sleeter said a meeting is scheduled for Friday at 1:30 P.M. with Mr. Knutson, Mr. Smith and Mr. Kuglitsch on the bid requirements. He said he feels the outcome will be to retrofit the current equipment working with the current vendor. He said he hopes to have a resolution to move forward with this project at the next meeting.

<u>Semi-Annual Report.</u> The Committee accepted the semi-annual report from Child Support.

<u>Discussion on Department Tours.</u> Chair Collins said he had not heard back from Department Heads on if they would like the Committee to tour their departments or not.

Mr. Sleeter said it would be better if the Committee could wait for better weather – possibly in April – before a visit to the 911 Communications Center is set.

Ms. Costrini-Norgal invited the Committee to visit Mediation and Family Court Services Department at any time.

Ms. Michaelis suggested the Committee wait until the Jail renovation is complete and suggested July.

Supervisor Brill asked Ms. Michaelis to take the Committee's thanks back to the Sheriff and staff on a job well done regarding solving the murder case so quickly.
