Authorizing Revision of Contract with ATTIC Correctional Services, Inc for Additional Drug Court Case Management and Treatment Services and Amending the Budget.

BE IT FURTHER RESOLVED, that a revised contract is authorized with ATTIC Correctional Services, Inc. for additional Case Management and Treatment Services for the Drug Court beginning on or about June 15, 2010, in an amount not to exceed \$26,347."

Supervisor Knudson moved approval of the above resolution, second by Supervisor Wiedenfeld. ADOPTED.

<u>Countywide Communications Upgrade – Update.</u> Mr. Sleeter said the kick-off meeting with the grant writers is scheduled for May 13th. He'll be meeting with Rock County Firefighters on May 12th regarding the Assistance to Firefighters grant. He said Mr. Boutwell received notification from Senator Kohl's office that the earmark will not be moving forward. Representative Baldwin's office is still looking at the earmark. The grant writers' office will continue to look for potential funding.

<u>Committee Requests and Motions.</u> Supervisor Brill said the Coroner's van was at the Employee Appreciation Day at the Public Works Department on April 29th and he noticed the gurney was not user friendly. He asked how we would go about getting a new one? Ms. Keach said she was planning on putting that into her 2011 budget request. Mr. Boutwell said Ms. Keach could send a non-budgeted capital budget request to the Administrator's Office.

Supervisor Brill asked if the Coroner used the County morgue if it would save money? Ms. Keach said it would save time and mileage costs if they used it for temporary storage. Mr. Boutwell said this was brought up in prior year's budgets and, from an operational standpoint, it was not found to be feasible.

Supervisor Wiedenfeld said a number of months ago he had asked about sending used uniforms to Haiti for their police authority to wear. Captain Chellevold said he would check with Captain Steeber to see if he has heard anything on this matter.

Chair Collins said it is time to start the round of department tours and asked the department heads to look at their schedules to see when a good time would be for them. He asked to have the information back for the next Committee meeting on May 17th.

<u>Adjournment</u>. Supervisor Brill moved adjournment at 4:34 P.M., second by Supervisor Wiedenfeld. ADOPTED.
