<u>Countywide Communications Upgrade – Update.</u> Mr. Sleeter said \$2.275 million is in the 2011 Recommended Budget for the change from analog to digital to meet the 2013 narrow banding deadline and position themselves for the future. They will hopefully be sending out an RFQ in December and have an engineer on board in January 2011.

2010 Rock County Jail Inspection Report. Captain Chellevold said the Jail Inspector was in on August 26th to do a walk through of the facility. They had previously sent the requested records to him. The Inspector was very happy and complimentary in the report, said we are doing a good job with the facility we have, and was very happy with the comments from the incarcerated about staff.

Supervisor Wiedenfeld told Captain Chellevold he was quite impressed with the report and the Sheriff's Office should be commended. He added that they have made progress in the past few years on the inspections.
