<u>Discussion of District Attorney Security Camera Request.</u> Mr. O'Leary said this is the second time his vehicle has been hit. This time it was a hit-and-run and had the camera been set-up to record the parking lot there would not be a question of who hit his vehicle he would not have the expense of fixing for it.

Mr. Leu said there is a Security Committee and what we have meets the Supreme Courts guidelines. He said we would need to have an engineering study done before we take any action to see what updating our system would entail. Mr. Terronez added that we will be referring this matter to the General Services Committee for an engineering study.

Supervisor Wiedenfeld said he feels this needs immediate attention. Supervisor Beaver said she agreed and that she thought it had already been done. Supervisor Knudson agreed.
