# PUBLIC SAFETY & JUSTICE COMMITTEE May 21, 2012

<u>Call to Order</u>. Chair Collins called the meeting of the Public Safety and Justice Committee to order at 4:00 P.M. on May 21, 2012 in Conference Room N-1 at the Rock County Courthouse-East.

<u>Adoption of Agenda</u>. Supervisor Knudson moved approval of the agenda as presented, second by Supervisor Brill. ADOPTED.

Citizen Participation, Communications, Announcement, Information. Supervisor Brown said he had received two calls from his constituents: 1) that signs had been put up at boat landings, but there were some big boats causing a great deal of wake and there was concern expressed on the enforcement of the slow-no-wake; 2) that 7.75 may be too low but there was a great deal of traffic on Saturday and Sunday and, again, there was expression of concern on the enforcement of the slow-no-wake.

Chair Collins asked Ms. Bondehagen to pass on to Sheriff Spoden these concerns and to see if the Sheriff's Office has enforcement out yet.
