Committee Reports.

2010 Annual Report - Mediation and Family Court Services No questions.

<u>Update on County's Slow-No-Wake Ordinance.</u> Mr. Kuglitsch handed out a draft copy of proposed *Boating and Safety Laws and Slow-No-Wake Restriction*, with the current wording struck through and the new wording underlined (attached). He said he sent it to the lake districts attorney and the Sheriff on Friday and has not had any response back at this time. He said this will create a stricter standard, as we must look at how it affects the entire County.

Supervisor Bill moved to forward this new Boating and Safety Laws and Slow-No-Wake Restriction to the municipalities, second by Supervisor Knudson. ADOPTED.

<u>Discussion of Possible Assistant District Attorney Layoffs.</u> Mr. O'Leary said the Assistant District Attorneys union president received a letter stating that they will be reduced 20%. OSHER sent out a notice that since the ADAs did not take the 8 furlough days, instead they took 5 furlough days they would be cut 20%. This past Friday the DOA sent a notice to the DAs that they would be laying off 20% of the ADAs. What exactly this means we don't know at this time, whether they will have to close one day per week or if they will lose a number of people. He said he feels when it happens it will happen rapidly, but again, we don't know what or when.

Supervisor Wiedenfeld said he felt the Committee should go on record in opposition to this. Mr. O'Leary thanked the Committee and said when he finds out what is happening he will let them know and ask for support at that time.

Supervisor Brill said this could affect the Judge's calendar. Mr. O'Leary said he is waiting to talk to Judge Daley until he knows what this will mean.

Committee Requests and Motions.

<u>Discussion on Department Tours.</u> Supervisor Wiedenfeld suggested a tour of the new section of the Jail.

<u>Adjournment</u>. Supervisor Knudson moved adjournment at 4:42 P.M., second by Supervisor Beaver. ADOPTED.
