PUBLIC SAFETY & JUSTICE COMMITTEE April 19, 2010

<u>Call to Order</u>. Chair Collins called the meeting of the Public Safety and Justice Committee to order at 4:01 P.M. on April 19, 2010 in Conference Room N-1 on the fifth floor of the Rock County Courthouse-East.

<u>Citizen Participation, Communications, Announcements, Information</u>. Ms. Keach said the Rx Round-ups in Beloit, Edgerton, Janesville and Milton were a success and they disposed of about 500 pounds of drugs, of which about 50 pounds were controlled substances.

Mr. Sleeter said the 911 Communications Center has a radio public service announcement series running on using the 911 system and not abusing it. They are currently in the second week and have about three more weeks to go.

<u>Jail Inspection Report – Courthouse Facility.</u> Captain Jegerlehner said this was an inspection of the holding facility in the Courthouse. The report shows the facility was clean, tested and working properly. He answered questions on the report.

<u>Countywide Communications Upgrade – Update.</u> Mr. Sleeter said all the arrangements have been made, the contract signed and they have everything to get started. They

are just waiting for the programs to open so they will know the rules and regulations of the grant. The earmark requests are in and they are also watching for available money.

Committee Reports.

<u>Mediation & Family Court – 1^{st} Quarter Report</u> Ms. Costrini Norgal said Security has been diligent and respectful of their needs. She said Jefferson County is changing their program and using Rock County as a model.

<u>Committee Requests and Motions.</u> Supervisor Wiedenfeld said this is the third year of the Drug Court and it has been very successful. He suggested this Committee make a formal request to have Judge Werner speak at the Wisconsin Counties Convention in September. Chair Collins said he could check on what their desire would be and if they would have any room left.

<u>Adjournment</u>. Supervisor Wiedenfeld moved adjournment at 4:34 P.M., second by Supervisor Brill. ADOPTED.
