BHRSC approved the three goals. This should be the focus of this committee's next meeting, as well as reviewing the mission statement with new members and how these goals fit with the mission statement.

Children's Community Options Program (CCOP)

Tera O'Connor referred to several handouts distributed to the group, the first of which is a letter from the state regarding our Five-year Plan for implementing CCOP. Two action points are made in the letter:

- Creating a description of the outreach procedures that will be used to ensure that the program will be made available to children with physical, emotional, and developmental disabilities. Work is in progress on how to accomplish this and how to integrate outreach into the plan.
- Appointing a local health department representative on the CCOP Advisory Committee. Dave from Public Health will serve in this capacity.

The second handout is CCOP Policies and Procedures (HSD No. 0852) of which Tera gave an overview and the third is general information about CCOP.

Feedback from the state is expected regarding how dollars will be used once the wait list goes away. Please review all of the materials provided today, in particular the procedure guide, as this group will have more discussion on this. Tera and Angela will highlight several points regarding CCOP at the next meeting.
