#### Awarding Quote for Outboard Engine and Amending Sheriff's Office Budget

# **Executive Summary**

The Sheriff's Office Boston Whaler boat is a vital rescue and patrol vehicle. The Boston Whaler is the primary patrol boat. The Boston Whaler is the only boat in the fleet with a dive door that effectively allows the dive team to deploy. It is crucial that this boat is in good working order for all emergency and non-emergency deployments.

The outboard engine in the Boston Whaler is failing. The Sheriff's Office recommends replacing the outboard engine in 2016. Originally the new engine was going to be requested in the 2017 budget.

The cost for a Mercury Marine 250 HP Verado four stroke outboard engine is \$10,995, after trade in. Funding will come the Department of Natural Recourses (75%) and from sales tax revenue (25%).

Per Recreational Safety Deputy Christopher Krahn, the Sheriff's Office purchased the Boston Whaler patrol boat package new in 2009. To replace the entire boat, motor, and trailer would cost the Sheriff's Office over \$70,000. Currently, the boat and trailer are in good working condition, but the motor is in need of replacement. The motor replacement would allow the Boston Whaler to remain in the fleet for years to come.

The Sheriff's Office solicited quotes from qualified vendors for the Mercury Marine 250 HP Verado outboard engine. The quotes were reviewed by the Rock County Sheriff's Office and the Rock County Purchasing Manager, with the recommendation that the quote be awarded to the lowest, most responsive and responsible quoter, Jerrys Sports Service Inc., of Beloit, Wisconsin.

## **Executive Summary**

# Authorizing Acceptance of Cops and Kids Foundation Grant

The Rock County Sheriff's Office has received a grant from the Cops and Bobbers fund, a component of the Cops and Kids Foundation, Inc. The Cops and Kids Foundation is an area nonprofit organization whose programs and services provide law enforcement with the tools and funding necessary to implement their award winning community service.

The grant is for \$1,000 and will be used to support the Rock County Cops and Bobbers fishing program. Various fishing supplies, boat rental, and other related materials will be purchased with the funds. Additionally, Cops and Bobbers will be providing fishing poles, life jackets, and T-shirts.

The primary goal of the Cops and Bobbers program is to teach kids how to fish. The cops are the hosts, and volunteers from the community can also assist. The goal of Cops and Bobbers is to get kids hooked on fishing rather than drugs and crime. Kids will get to interact with local cops and form a positive and friendly relationship.

The Cops and Bobbers events will be held at different locations throughout Rock County. No additional County funds are needed.

This memo is to update the Committee on the Rock County Medical Examiner's Department and I plan to be available at the Committee meeting to respond to your questions.

The partnership between Rock and Dane Counties was solidified in 2015. During initial research and review of historical records, estimates were included in the Intergovernmental Agreement (IGA).

# **Review of Rock-Dane Counties Intergovernmental Agreement**

The Intergovernmental Agreement (IGA) between Rock and Dane Counties outlines the services that Rock County contracts with Dane County for. I have attached the 1<sup>st</sup> four pages and Schedule A of the IGA for your information. (See Attachment #1.)

# 2015 Activity

As was discussed in the early stages of this partnership, the difficulty associated with estimating workload is substantial. Especially difficult to estimate is the comparative judgement between a lay Coroner or Medical Examiner and a Forensic Pathologist Medical Examiner when assessing the need for forensic autopsy and testing.

Based on historical information that Rock County death investigations was estimated at 85 autopsies in 2015. The IGA called for 85 autopsies but allowed a range of 75 to 95 autopsies without having to reconcile the variance. In 2015 the Medical Examiner conducted 128 autopsies and Rock County was invoiced an additional approximately \$65,000 for 33 additional autopsies over and above the 95 that were included in the first year of the IGA. Fortunately, savings primarily in staff costs allowed for transfers to occur within the department's budget.

In 2015 the Medical Examiner or one of the other forensic pathologists cleared more than 750 cases for Rock County as part of the Forensic Case Review portion of the IGA. The IGA estimated that physicians would be clearing 500 cases. There is no language in the IGA that requires Rock County to compensate Dane County for the Forensic Case Review overage.

# INTERGOVERNMENTAL AGREEMENT BETWEEN DANE COUNTY AND ROCK COUNTY FOR MEDICAL EXAMINER SERVICES

This Intergovernmental Agreement ("Agreement") is entered into by and between Dane County, whose address is c/o Medical Examiner's Office, Public Safety Building, Room 2144, 115 W. Doty Street, Madison Wisconsin, and Rock County, whose address is 51 South Main Street, Janesville, Wisconsin, both quasi-municipal corporations in the State of Wisconsin.

# **RECITALS:**

WHEREAS, Rock County will be transitioning from a Coroner's Department to a Medical Examiner's Department beginning on January 5, 2015; and

WHEREAS, Rock County currently receives autopsy services from the Dane County Medical Examiner's office and is interested in appointing Dane County's Chief Medical Examiner and Deputy Medical Examiner to provide Medical Examiner services in Rock County; and

WHEREAS, Rock County would also like to enlist the services of Dane County's Director of Operations for its Medical Examiner's Department to provide administrative services to Rock County; and

WHEREAS, Dane County is interested in providing these services to Rock County as part of a cooperative agreement.

WHEREAS, it would be beneficial for both parties to share resources and expertise to perform the statutory duties of a Medical Examiner; and

WHEREAS, Dane County and Rock County desire to enter into an agreement whereby the Dane County Medical Examiner's Office will provide Medical Examiner services, autopsy medicine, oversight and administrative services for and on behalf of the Rock County Medical Examiner's Department; and

WHEREAS, the parties are authorized to enter into this Agreement pursuant to section 66.0301, Wisconsin Statutes

**NOW THEREFORE**, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is acknowledged by each party for itself, Dane County and Rock County do agree as follows:

#### 1. **DEFINITIONS**.

- a. "Autopsy-related Services" shall mean the autopsy, digital photos and digital x-rays, where appropriate, for adults and children. It shall also include round-trip transportation from Rock County to Dane County and expert testimony in cases involving criminal prosecution. The cost of x-rays performed outside of the Medical Examiner's Department shall not be included in the services covered pursuant to this Agreement.
- **b.** "Mass Fatality Event" shall mean more than five deaths resulting from a single event.

- f. To participate in the hiring process for Rock County administrative and investigative staff in the Medical Examiner's Department and to make recommendations as to hiring decisions;
- g. Beginning on or about November 1, 2014, to provide initial training in Dane County for new MLI staff. Rock County shall be responsible for all costs associated with training which include, but are not limited to, salaries, benefits and transportation costs for its employees.
- h. To review and make recommendations for staffing levels of the Medical Examiner's Department to establish adequate coverage;
- i. To facilitate training in death investigations and recommend outside training for investigative staff;
- j. To work with Rock County to address any current or future issues regarding the operation of the Medical Examiner's Department;
- k. To work closely with Rock County and the appropriate oversight committees to perform the functions required pursuant to this Agreement.

#### 5. CASE REVIEW AND AUTOPSY SERVICES:

- a. Dane County's Chief Medical Examiner and Deputy Medical Examiner shall perform the statutory functions of Medical Examiner in Rock County;
- b. During death scene response or other death investigations, the Director of Operations for Dane County will work with Rock County staff to establish case review protocols, and to facilitate communication with the Dane County Medical Examiner to allow for case triage. The Chief Medical Examiner from Dane County will work with medicolegal death investigators to determine whether an autopsy or additional forensic examination should take place. Consideration will be given to the needs of other criminal justice partners, and the statutory authority of the District Attorney to independently order an autopsy will be recognized and followed.
- c. Dane County shall provide a forensic pathologist response to homicide cases or other cases where a complicated scene examination is appropriate. The need for this response shall be determined by the Medical Examiner in consultation with those at the scene;
- d. Dane County shall provide autopsy-related services pursuant to this Agreement. Toxicology panels, all histology, infant x-rays and subsequent interpretation, and any other specialized testing shall be billed directly to Rock County and are not included in this agreement.

## 6. GENERAL SERVICES.

- a. Specific scheduling of the tasks and responsibilities identified herein shall be established by mutual agreement of the parties.
- b. Each party shall commence, carry on and complete its obligations under this Agreement with all deliberate speed and in a sound, economical and efficient manner, in accordance with this Agreement and all applicable laws. In receiving services under this Agreement, each party agrees to cooperate with the various departments, agencies, employees and officers of the other.

# STAFFING AGREEMENT FOR OPERATION OF THE ROCK COUNTY JAIL

This agreement is entered into between Sheriff Robert D. Spoden and the Rock County Board of Supervisors for the purpose of jointly agreeing upon the minimum staffing levels needed to ensure the health, safety, and security of the staff and inmates at the Rock County Jail. This agreement addresses the requirement of Wisconsin Administrative Code Chapter DOC 350.20(1) which states, "The county board and sheriff shall determine jointly the adequate staffing needs, including support staff and services that are required to ensure the health, safety, and security of the jail staff and inmates when using cells for double occupancy. The joint determinations shall be in writing and signed by the representatives of the county board and the sheriff and shall be filed with the department. The written joint determination shall remain in effect until rescinded or amended by mutual written agreement of the county board and sheriff. Unless there is adequate staff as agreed upon by the county board and sheriff, double celling may not occur."

The terms of this agreement are as follows:

- 1. First Shift (7 a.m. -3 p.m.) shall operate with a minimum of the following staff:
  - ☑ 14 Officers
  - ☑ 1 Supervisors (Sergeants, Captains, etc.)
  - ☑ 1 Healthcare Staff
  - 2 Clerical/Support/Program Staff
- 2. Second Shift (3 p.m. -11 p.m.) shall operate with a minimum of the following staff:
  - ☑ 14 Officers
  - ☐ 1 Supervisors (Sergeants, Captains, etc.)
  - I Healthcare Staff
  - 2 Clerical/Support/Program Staff
- 3. Third Shift (11 p.m. -7 a.m.) shall operate with a minimum of the following staff:
  - ☑ 10 Officers
  - ☑ 1 Supervisors (Sergeants, Captains, etc.)
  - ☑ 1 Healthcare Staff
- 4. The above listed staffing plan is representative of shifts during the normal (Monday Friday) work week. Staffing levels on weekends and holidays for 1<sup>st</sup> and 2<sup>nd</sup> shift are fifteen officers, one supervisor and one healthcare staff member.
- 5. In compliance with WI Statute §302.41, there shall be at least one officer/deputy on duty of the same gender as those incarcerated at the jail.
- 6. It shall be understood that the aforementioned staffing determination is the minimum necessary to operate the Rock County Jail, and that unforeseen circumstances to facility operations may require additional staffing to ensure the safety of the inmates and staff.

# MINIMUM STAFFING LEVELS FOR THE ROCK COUNTY JAIL

#### EXECUTIVE SUMMARY

Wisconsin Administrative Code DOC 350.20 (Double Celling) establishes that a written agreement must be in place between the sheriff and county board as to the minimum staffing levels required to safely operate the jail.

On 09-07-89, The State of Wisconsin granted the Rock County Sheriff's Office permission to double cell inmates. In order to continue to double cell inmates, this written agreement must be filed with the Wisconsin Department of Corrections. It shall remain in effect until rescinded or amended by mutual written agreement of the County Board and Sheriff.

This agreement is cost neutral as it does not increase or decrease staffing levels as established in the adopted county budget.

# **PURPOSE**

The purpose of this General Order is to establish guidelines for double celling at the Rock County Jail. The following General Order conforms to the requirements of Wisconsin Administrative Code DOC 350.20 (Double Celling).

# **POLICY**

The Rock County Sheriff's Office is committed to complying with the requirements found in the Wisconsin Administrative Code DOC 350.20 as it relates to Double Celling.

# **DEFINITIONS**

**Written Joint Determination** - For the purpose of double celling, Written Joint Determination shall be defined as staffing levels identified in the adopted county budget.

#### **PROCEDURE**

A. The County Board and Sheriff shall determine jointly the adequate staffing needs, including support staff and services, which are required to ensure the health, safety and security of the jail staff and inmates when using cells for double occupancy. The Written Joint Determination shall be in writing and signed by the representatives of the County Board and the Sheriff and shall be filed with the Wisconsin Department of Corrections. The Written Joint Determination shall remain in effect until rescinded or amended by mutual written agreement of the County Board and Sheriff. Unless there is adequate staff as agreed upon by the County Board and Sheriff, double celling may not occur.

- B. Inmates housed in the same cell shall have the same custody classification and be properly segregated as required under WI ss. 302.36.
- C. For male and female housing areas, at least one cell or 15% of the jail's total number of cells, whichever is greater, shall be maintained for single occupancy.
- D. Receiving cells may not be used for double occupancy.
