Review and Possible Action on In Rem Foreclosure Booklet, Procedures and Pending Litigation. Ms. Kleinheinz said there are currently 101 properties and 74 stops. She said today is the last day to pay and she will be putting the books together Friday.

Ms. Timmerman said the County will be doing a supplemental procedure this year as there is a property in Beloit that is partially owned by a company that is no longer in business, which was recently released by the Bankruptcy Court to be sold.

Ms. Timmerman said the properties will be going before Judge McCrory on September 6 and then reassigned to Judge Grubb.

Ms. Timmerman briefly went over the process; said that everything to date has been filed and mailed; three affidavits will need to be filed with the court; and that she did not believe there are any contaminated properties this year. Ms. Timmerman said there are nine properties with federal liens on them and we will need to wait on these 120 days after the court hearing before going to auction. Ms. Timmerman said, after the court hearing, the Corporation Counsel's Office will send out letters to let people owning/living at these properties know they need to leave everything as is and not to remove or destroy anything.

Supervisor Fox confirmed that the Finance Committee will be meeting at the Council on Aging at 7 A.M. Monday morning for the tour.
