CHANGING THE HALL OF HONOR FROM AN ANNUAL PROCESS TO ONCE EVERY TWO YEARS

EXECUTIVE SUMMARY

Since 1982, the Rock County Board of Supervisors has chosen to honor a maximum of three residents each year as inductees into the Rock County Hall of Honor. In recent years, the County has received few nominations and in 2017, the Hall of Honor ceremony was cancelled because there were no nominations. It is believed that altering the Hall of Honor process to take place every two years may increase interest and allow more time for residents to submit nominations.
