#### Updates.

Request for Authorization to Purchase Network Switches and Networking Adapters from CoreBTS Supervisor Fox moved approval of the request to purchase network switches and networking adapters from CoreBTS for a total not to exceed \$21,508.20, second by Supervisor Podzilni. ADOPTED.

<u>Update on In Rem Foreclosure Properties</u> Ms. Roettger and Ms. Kleinheinz said the owners have until 10:59 AM today to pay in full. Ms. Kleinheinz said, at this time, they are taking 53 parcels, of which 4 have federal tax liens and an additional 27 are on hold.

Discussion on title searches.

<u>Update on Agenda & Minutes Software Project</u> Mr. Greenlee said the County contracted with Accela for agenda and minutes software, had a few issues with the programs, went back and forth with discussions on how to resolve the issues, they were then bought out by Granicus, we gave them a list of our needs, and have not heard back from them. We have followed up twice with e-mails to them and have not heard back. In the meantime, Granicus

has purchased three more companies. He said it is probably time to cut ties with them and move on.

Ms. Tollefson said we more than likely will need a separate company for the voting.

Review of 2018 Budget through July Ms. Oja went over the Budget to Actual reports, answered questions, and said these departments are pretty much on track with where they should be at this time in the year.

Supervisor Yeomans asked about having the figures from last year for the same months added to the report. Ms. Oja said she would see if we are able to have this column added to the report for next time.

<u>Adjournment</u>. Supervisor Fox moved adjournment at 7:57 A.M., second by Supervisor Beaver. ADOPTED.
