# TO REQUEST FUNDING FROM THE GENERAL FUND AND MODIFY THE 2016 DEVELOPMENTAL DISABILITIES BOARD BUDGET AND INCREASE THE CESA-2, BIRTH-TO-THREE PROGRAM

WHEREAS, the Developmental Disabilities Board has contracted with CESA-2 to operate the State
 mandated Birth-to-Three Program for Rock County in CY 2016; and,

WHEREAS, the award of 2016 funds in the amount of \$902,901 from Purchase of Care 33-3310-0000-62601 will be paid to CESA-2 by the Developmental Disabilities Board in 2016; and,

WHEREAS, CESA-2's costs for operating the Birth-to-Three program for the first six months of 2016 has exceeded the CY2016 budgeted amount by \$84,929; and,

WHEREAS, the Developmental Disabilities Board is requesting to use \$84,929 of the County's General Fund to fund the therapy component of the Birth to Three program due to the initial start-up costs, increased number of children receiving therapy and multiple therapy services and the transition of services from a previous provider to CESA-2 in CY2015; and,

WHEREAS, the State of Wisconsin's Birth to Three Program, Bureau of Children's Services, DHS, has agreed to work closely with Rock County and specifically, CESA-2, to identify ways to reduce costs and increase billing revenue, and,

WHEREAS, the CESA-2 anticipates a budgetary shortfall the last six months of CY2016 resulting in a second request for a funding increase to reconcile the actual costs for operating the program; and,

WHEREAS, the increased funding in the amount of \$84,929 will address the budgetary shortfall in the Rock County Birth to Three Program for the first half of 2016.
