### **Updates and Possible Action.**

Potential Remediation of 110 S. Water Street Site Mr. Smith explained the County received a letter from the DNR in mid-February regarding the old Jail site on Water Street and contamination found at the site. The property was sold in the late 1980s and is now owned by a private developer working with the City of Janesville. The City of Janesville sent a letter to let the County know they have hired Sigma Group to conduct Phase 1 work in relation to this property. Mr. Smith said he has a call in to the DNR, but has not yet heard back from them, to see if the letter from the City of Janesville is satisfactory.

Chair Mawhinney informed the Committee that the financial consultants will be at the next meeting.
