

### FINANCE COMMITTEE Minutes – June 4, 2020

<u>Approval of Agenda</u>. Supervisor Fox moved approval of the amended agenda, second by Supervisor Davis. ADOPTED.

<u>Approval of Minutes – May 21, 2020.</u> Ms. Roettger said the bank contract should be extended to July 1, 2021 not July 31, 2021.

Supervisor Purviance moved approval of the minutes of May 21, 2020 with this change, second by Supervisor Fox. ADOPTED with this change.
