BE IT FINALLY RESOLVED that the Department of Public Works Parks Division 2017 Budget be amended as follows:



<u>Discussion and Possible Action on Approval Process of Per Meeting Allowances.</u>
Ms. Oja explained that when one of the past Finance Committee meetings had not been held the Per Meeting Allowances had been paid and then put on the next agenda for review. She asked the Committee if this were to occur at a future time if this is how they would like it handled. The Committee felt the County Board Rules should be amended to include the Per Meeting Allowances must be approved by the Finance Committee before being paid.

<u>Discussion and Possible Action on Surveyor's Change Fund.</u> Ms. Oja informed the Committee that the Surveyor's Office has a change fund of \$10 and when someone pays for a map or copy with a twenty dollar bill they do not have enough to make change.

Supervisor Fox moved approval to increase the change fund for the Surveyor's Office to \$50, second by Supervisor Podzilni. ADOPTED.

Report on Cash Balances and Investments. Ms. Oja handed out copies and updated the Committee on cash balances and investments as of February 28, 2017.

The Committee discussed having a third party vendor to provide credit card services for the use of credit cards for the collection of fees, payments, etc.
