Supervisor Podzilni moved Committee approval of the above resolution, second by Supervisor Kraft. ADOPTED.

Discussion and Possible Action on Board Rules of Procedure Changes. Ms. Oja handed out copies (attached) of requested changes to the Rock County Board Rules of Procedure and went over them with the Committee. Ms. Oja said our process, as it is now, can take five to six weeks from when a request is entered for payment and when the check is actually cut. She added that if the bill is over \$10,000 the process can take even longer. This is not as much a problem for larger businesses but for small business this can sometimes be an issue. Ms. Oja added that this also has an impact on businesses bidding on projects as they don't want to, or cannot, operate under these rules as they are now. Ms. Oja also went over a matrix of comparable counties in WI and how they review and pay bills. Ms. Oja went over possible Committee Review Reports and a Budget to Actual Report.

Supervisor Fox asked if the County is offered any early payment discounts. Ms. Oja said we are offered these discounts but the County has very rarely been able to take advantage of them.

Supervisor Fox moved to approve the proposed changes as presented, second by Supervisor Podzilni. ADOPTED.

Ms. Oja said she is planning on attending as many other committee meetings as possible to go over these proposed changes.

Report on Cash Balances and Investments. Ms. Oja handed out copies and updated the Committee on cash balances and investments as of February 29, 2016 and County Sales Tax Receipts through February 29, 2016.

Ms. Oja informed the Committee that Cutwater will be coming to the April 7, 2016 Finance Committee meeting.

Adjournment. Supervisor Fox moved adjournment at 8:25 A.M., second by Supervisor Beaver. ADOPTED.
