FINANCE COMMITTEE March 4, 2010

<u>Call to Order</u>. Chair Mawhinney called the meeting of the Finance Committee to order at 7:30 A.M. on Thursday, March 4, 2010, in Conference Room N-1 on the fifth floor of the Rock County Courthouse-East.

<u>Committee Members Present</u>. Supervisors Mawhinney, Kraft, Beaver, Diestler, Podzilni.

Committee Members Absent: None.

<u>Staff Members Present</u>. Jeff Smith, Finance Director; Jeff Kuglitsch, Corporation Counsel; Sherry Oja, Senior Accountant/Assistant to the Finance Director; Michelle Schultz, Real Property Lister; Mickey Crittenden, Information Technology Director; Vicki Brown, Treasurer; Kris Baker Ellis, Child Support Director (7:46 AM).

Others Present: Ryan Barbieri, Willis HRH; Richard Choyke and Marc McClure, Cutwater Asset Management.

<u>Approval of Agenda</u>. Mr. Smith said there was a Bill for Other Departments – General Services to Alliant and a Pre-Approved Encumbrance Amendment for General Services. Supervisor Podzilni moved approval of the agenda with these additions, second by Supervisor Diestler. ADOPTED.

<u>Committee Review and Approval of Per Meeting Allowances.</u> Supervisor Beaver moved approval of Per Meeting Allowances in the amount of \$13,014.31, second by Supervisor Diestler. ADOPTED.

<u>Approval of Minutes</u>. Supervisor Kraft moved approval of the minutes of February 18, 2010 as presented, second by Supervisor Podzilni. ADOPTED.

<u>Citizen Participation, Communications, Announcements, Information</u>. Mr. Smith said he will not be at the next meeting, Ms. Oja will be there instead.

<u>Selection of Specific Pricing Model for Care Coordination Services Through Quantum Health – Ryan Barbieri, Willis, HRH.</u> Mr. Barbieri handed out a fee proposal with four options and a handout of three different scenarios and the results using each of the options.

Mr. Smith informed the Committee that he, Mr. Kuglitsch, Mr. Knutson and Mr. Barbieri had reviewed the four options and all felt Option 3 would be the most advantageous for the County. He added, per the resolution, the Finance Committee is to select the best option for Rock County.

Supervisor Diestler asked if this is to make the transition easier for the employees? Mr. Smith said Coordinated Health/Care (CHC) is to have the employee work with one entity (CHC)

and CHC will then work with medical personnel to make sure there are no duplication of tests, etc. to eliminate waste.

Mr. Smith added, as part of the Alliance, the County is getting a 5% discount.

Supervisor Kraft moved to accept the recommendation of staff and go with Option 3, second by Supervisor Podzilni. ADOPTED.

Report on MBIA Investments – Marc McClure. Mr. McClure handed out the Rock County Investment Management Program Review. He went over the Market Environment and Strategies commenting that it will probably remain about the same for at least the next 6-9 months. Unemployment figures, which do not include the under-employed, part timers and those who have given up on employment, probably will take about 5 years before we really see them come back up. He went over Rock County's portfolio and Ms. Brown mentioned that the balance is down here primarily because the County could get better rates with CD's. Mr. McClure said Rock County has a very liquid portfolio and he would like to see more call dates, step-ups and some non-call investments in to help protect the portfolio.

Ms. Brown asked Mr. McClure to go over First National Bank & Trusts analysis. Mr. McClure said they are very well capitalized. Mr. Choyke added if the Highline Peer Group Rating is over 30 it should be pretty good as long as it has consistently been there and is not on a continuous downward trend. First National Bank and Trust Highline rating is at 49 as of September 2009.

Mr. McClure explained that the last item is the Investment Policy for Rock County and for Mr. Smith and the Committee to go over these changes, which for the most part are just renumbering and adding "or the equivalent" after the ratings.
