Consideration of Policy Regarding the Eligibility of Property Owners with Redemption Taxes Owed Rock County to Purchase Property at Public Tax Lien Sale Ms. Brown requested a change to the policy because there are people with redemption taxes owing who have bid on property in the past and these properties are now overdue. This would affect the people who have a tax lien on a property(s) and wish to purchase foreclosure property(s). The people wishing to purchase properties being foreclosed on would need to register ½ hour prior to the auction to give her office time to check to see if they have any redemption taxes due. This new policy rule would be read with the rest of the rules at the opening of the auction.

Supervisor Kraft moved approval of this new policy to bar people with redemption taxes due Rock County from bidding on or purchasing the tax lien sale properties, second by Supervisor Beaver. ADOPTED. Chair Mawhinney asked Ms. Brown to bring this back for review in a year.
