You have been referred to use through a "Drug Court" contract—a written agreement between you, your attorney and the district attorney's office. This contract may specify that your current pending charge(s) may be dismissed, significantly reduced, or sentencing concessions made upon successful completion of this program. Your enrollment in the program is voluntary. You will also be evaluated to see if you qualify for enrollment.

During your time in the program you will be enrolled in AODA and Moral Reconation Therapy (MRT) groups. Other specialized curricula may be made available as needed. You will also meet with your case manager on a weekly basis for individual counseling sessions. To assist you further we may make referrals for you regarding employment, housing, and education. If you are employed, we will do our best to schedule your classes and case management meetings around your work hours.

This program requires a significant time commitment on your part and will last a minimum of 14 months, depending on your needs and personal progress. The program consists of five phases: Acute Stabilization, Clinical Stabilization, Pro-Social Habilitation, Adaptive Habilitation, and Continuing Care, and will also include and aftercare component. You will be a signed a personal identification number (PIN) for random drug and alcohol testing and given a form indicating the number to call along with the dates, times, and locations of testing. You are initially required to "check-in" at the Drug Court office on a <u>daily</u> basis, **Monday through Friday.** A "check-in" is when you come into the office and make contact with a staff member and sign the sign-in sheet. A "check-in" can take a few minutes, or an hour or more, depending on whether you have a class or meeting with your case manager. The office is open from 9:00 a.m. to 7:00 p.m. Monday through Friday, and 10:00 a.m. to 2:00 p.m. on Saturdays. You will appear before the Drug Court Judge each Thursday morning at 8:00 a.m. for a review of your treatment progress.

The Acute Stabilization phase will last approximately (2) two months, or until you meet the criteria to move on to the next phase. The Clinical Stabilization phase, the **Pro-Social Habilitation** phase, the **Adaptive Habilitation** phase, and the **Continuing Care** phase will <u>each</u> last approximately (3) three months, or until you meet the criteria to move on to the next phase. Depending on your progress, as you move throughout the phases, you will be required to report to the office less often and your court appearances may be reduced. Drug testing will remain frequent and random throughout all phases.

Throughout the program it is your responsibility to obtain suitable transportation to and from the Drug Court office.

You will be required to attend and be on time for all groups, scheduled drug tests, treatment sessions and Court appearances. Note that case management may occur in your home, at the drug court office or in the community.

Sanctions and/or treatment responses may be imposed for Program rule violations. Sanctions may include written assignments, community services, or 24-96 hours in jail for each violation. Treatment responses may include more frequent reporting to your Case Manager or the treatment office, addition of groups, or repeating steps in MRT. Program compliance will result in positive actions such as less reporting to your Case Manager and movement to a less restrictive phase. Ultimately, program compliance will lead to successful program completion and the benefits agreed upon in your contract.

Your success in the Program will depend on your willingness to:

- Remain drug and alcohol free
- Attend all required classes and be on time
- Cooperate with the treatment plan designed with and for you

An initial fee of \$100.00 is required when you start the Drug Court program. You will then be required to pay \$10.00 each week towards your treatment costs. **Payments will only be accepted in the form of check or money order.** Fees are waived for DOC clients.
