MINUTES OF BOARD OF HEALTH MEETING

August 7, 2019

Call to Order: Meeting was called to order by Chair Peer at 6:00 p.m.

Board of Health Members Present: Supervisor Peer, Supervisor Gramke, Supervisor Rynes, Supervisor Homan, Dr. Meyers, Dr. Winter, Dr. Somaraju, and Mr. Gresens.

Board of Health Members Absent: Ms. Wade

Staff Members Present: Marie-Noel Sandoval – Health Officer; Rick Wietersen – Environmental Health Director; Sydney Resler – AHEC Intern; and Jessica Turner – Administrative Services Supervisor.

Others Present: None at this time.

Adopt Agenda

Supervisor Rynes made a motion to adopt the agenda. Dr. Winter seconded the motion. MOTION APPROVED.

Approval of Minutes – 7/10/19

Supervisor Rynes made a motion to approve the minutes of the 7/10/19 Board of Health meeting. Dr. Meyers seconded the motion. MOTION APPROVED.

Citizen Participation

Ms. Resler introduced herself. She is currently an intern at the Rock County Public Health Department.

New Business

Administrative Division

Review of Payments

The Board reviewed the Health Department's July payments in the amount of \$29,983.11.

Transfer of Funds over \$5,000

None at this time.

Health Department Report

In the News

Ms. Sandoval reported that the Janesville Gazette ran an article that highlighted a trend of increased opioid overdoses.

Surveillance

Ms. Sandoval had nothing to report.

Community Events/Outreach

Ms. Sandoval stated that Ms. Bailey talked last month about a survey taken at Juneteenth and Freedom Fest to get the voice of the customer. There were 93 respondents who provided valuable information from a population that we don't normally reach. There was a drawing for a \$25 gift certificate at each event as an incentive to complete the survey.

Ms. Sandoval told the Board that she attended the NACCHO annual conference. She said it was a great conference, and she attended sessions focused on workforce development. The Rock County Public Health Department received a shout out from Dane County in one of the presentations.

Ms. Sandoval reported that there is a statewide Public Health Emergency Preparedness exercise on 9/26 focusing on points of dispensing (POD). The Public Health Department is working on Memorandums of Understanding for open POD to provide vaccine to the public in emergency situations. They are inviting partners to join in the exercise.

Ms. Sandoval said that a new sign board has been put up to replace the old one that was falling apart.

Ms. Sandoval told the Board that she attended an introductory meeting to meet the new CEO of the YMCA and discuss chronic disease interventions. The new CEO is excited about public health.

Budget

Ms. Sandoval reported that the 2020 budget documents have been submitted. She said that the request is approximately \$230,000 more than 2019 due to the insurance changes (\$65,000 increase), I.T. restructuring (\$25,000 increase), and pay increases (5% increase). The Board discussed the insurance changes. Ms. Sandoval stated that the line by line meeting is tomorrow. She said the department has brought in more grants, the immunization clinic is not bringing in as much, cuts have been made in other areas, and she can cut some money based on average vacancies. She told the Board that technology is important because it has made the Public Health Department more eligible for grants. Mr. Gresens asked if technology can replace staff. Ms. Sandoval said that it cannot, but it can help staff become more efficient and effective. Ms. Sandoval added that she is asking for the following reclassifications: combine two .4 Environmental Health positions into one full time position which will create an increase in salary, and convert a vacant Nurse position to a Marketing Communication Specialist to better communicate with partners, media, and the public. The marketing position would be a decrease in salary. Chair Peer talked to the Board about referring media to the Public Health Department or the Board of Supervisors.

According to Ms. Sandoval, on June 27th the budget bill passed senate and was signed into law on July 3rd. The budget included nitrate funding for homeowner wells. Approximately three million dollars was set aside. Mr. Wietersen added that this will be similar to the well compensation fund. Supervisor Rynes asked about PFAS testing. Mr. Wietersen responded that the Rock County Public Health Department does not do PFAS testing, but targeted locations do get tested. Mr. Wietersen added that everyone is at the early stages of learning about

PFAS. Ms. Sandoval said that the budget also included E-cigarette taxation based on weight and the Hintz bill to get rid of personal conviction immunization waivers. The Wisconsin Association of Local Health Departments and Boards is working on a template resolution for local departments to use. Fond du Lac has passed a resolution. The Board members discussed the E-cigarette taxation. Ms. Sandoval said that Kenosha, Waukesha, and Milwaukee Counties have had reports of lung diseases associated with vaping.

Personnel

Ms. Sandoval reported that Kelly Klingensmith resigned as Community Health Education Coordinator and relocated to Chicago. Interviews were conducted last week for her position. Three candidates were interviewed.

Ms. Sandoval told the Board that she has renamed the Public Health Nurse Supervisor position to Public Health Supervisor. She said they have struggled to get candidates under the old title. There have been two vacant positions since January. According to Ms. Sandoval there have been eight applicants so far with the new title. Supervisor Homan asked if it presents a problem if someone without a nursing degree comes in and supervises nurses. Ms. Sandoval said no. They need someone to manage programs. The nurses are the subject matter experts.

Ms. Sandoval presented certificates of appreciation to Dr. Somaraju and Dr. Winter. The other Board members were presented certificates at a previous meeting.

AHEC Intern Presentation

Mr. Wietersen introduced Ms. Resler. She told the Board a little about herself.

Ms. Resler gave a PowerPoint presentation on her internship with the Rock County Public Health Department (see attached).

Mr. Wietersen explained that the Rock High School intern could not make it to present tonight. He explained the Rock Intern program. This intern worked on surface water sampling, well sampling, pool chemical checks, the rabies program, and some data entry. He will be a senior at Janesville Craig. The last Rock High School intern that the Public Health Department had went into an environmental field.

Chair Peer told Ms. Resler she had a very good presentation.

Mr. Wietersen added that the Public Health Department just received a grant within the last week to follow-up as Ms. Resler has suggested.

Dr. Somaraju gave a travel tip. When on vacation, book a room on the 3rd floor or above. Mosquitos can only fly 60 feet high.

Adjournment

Supervisor Gramke made a motion to adjourn the meeting. Dr. Meyers seconded the motion. MOTION APPROVED. Meeting adjourned at 7:22 p.m.

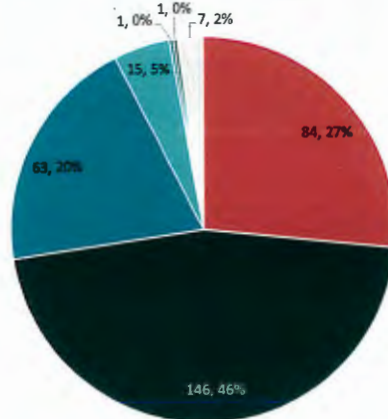








Species of Mosquitos Identified Between June 6 and August 7, 2019

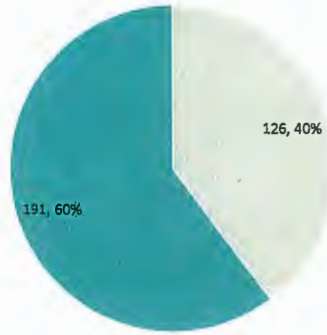

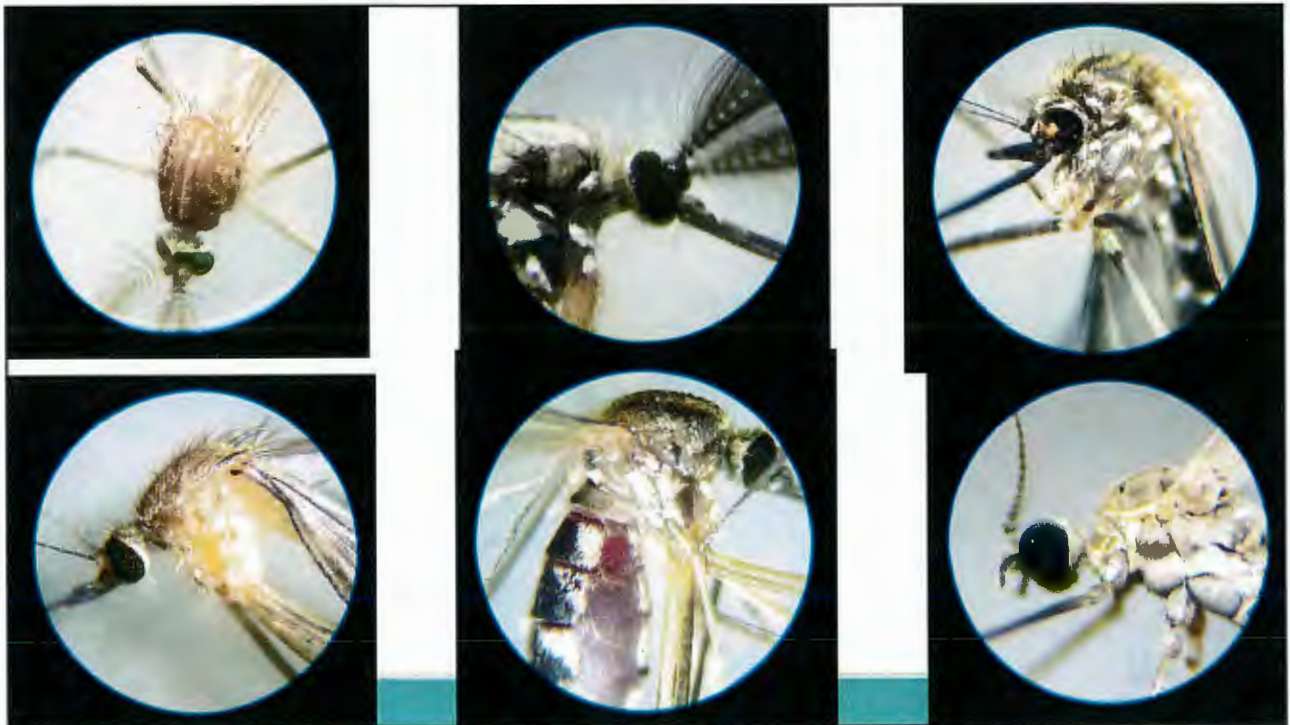

Male ■ Female

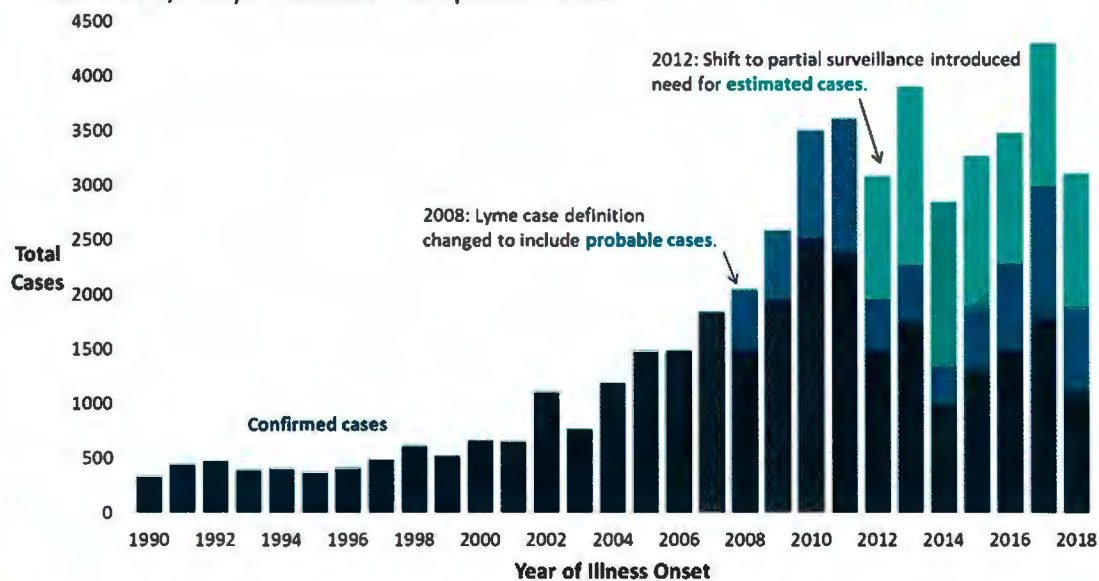

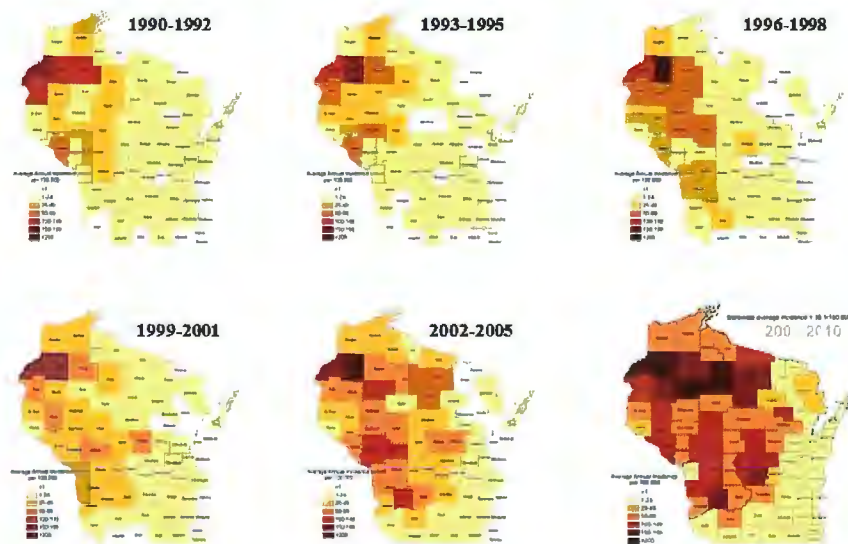
Lyme Disease (*B. burgdorferi*) Cases in Wisconsin

Existing Tick Surveillance Programs

North Dakota Department of Health

2017¹

Contacted 28 veterinarians and zoos about collecting and submitting ticks (passive surveillance)

1,744 ticks submitted

2018²

Expanded to 37 vets and zoos, 16 Wildlife Services, and 7 Game and Fish sites (passive surveillance)

One active surveillance person doing tick drags

13,692 ticks submitted (7,266 from passive, 6,426 from active)

University of Illinois Tick Inventory Collaboration Network (I-TICK)³

2018 – collected over 900 ticks from 28 counties through public submission and active surveillance

Existing Tick Surveillance Programs (cont.)

K-9 Initiative in State College, PA⁴

Educate officers about tick prevention and removal on dogs, ask them to submit ticks they may find

Pennsylvania Task Force on Lyme Disease and Related Tick-borne Diseases⁵

Recommendations to improve tick awareness throughout the state

Engage schools, students, parents in education and tick checks

Educate park staff on management strategies

Create education materials for physicians to hand out

Healthcare provider education and awareness

Update diagnostic testing and notifiable disease list to include more tick-borne diseases

Public awareness campaign

Find funding to increase research, surveillance, data collection in case investigations, observational studies



Public Health

Next Steps for Rock County

Education

Update RCPHD website to include tick-borne disease data, tick bite prevention, tick removal and collection efforts

Create and distribute educational materials (posters, press releases, info cards, Tick Kits)

Build course for healthcare providers on tick-borne diseases to increase awareness and testing (CME credits, grand rounds)

Identify trailheads, parks, camp grounds, outdoor stores, etc. and post information about tick prevention, removal, possibly submission

Train county and city parks staff on tick prevention and management strategies

Next Steps for Rock County (cont.)

Passive Surveillance

Create standardized form/template for gathering this information

Use Tick App as a guide?

Identify and contact veterinarians, pet groomers, K-9 units

Post information in hunting/outdoor stores for hunters

Include this information in training for parks staff

Active Surveillance

Identify locations for seasonal tick drags

Research alternative trapping methods

Utilize students from local colleges and universities

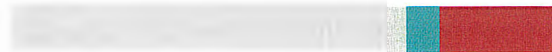


ED visits with oral health diagnoses, 2017 (Mercy Hospital, Beloit Health & SSM Health)

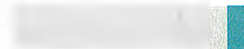
ED visits for selected oral diseases main diagnosis (e.g. gingival, caries, pulp/infection)

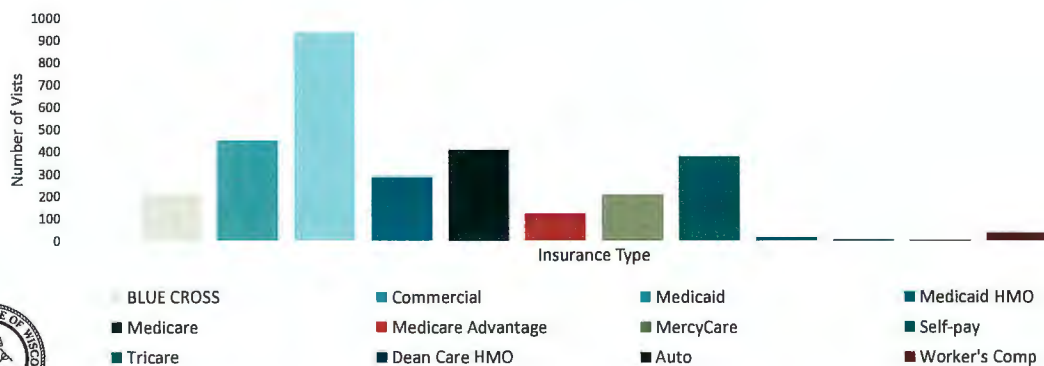

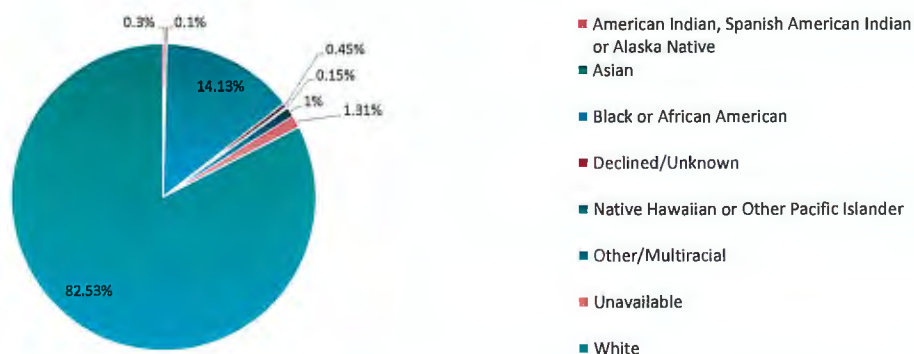

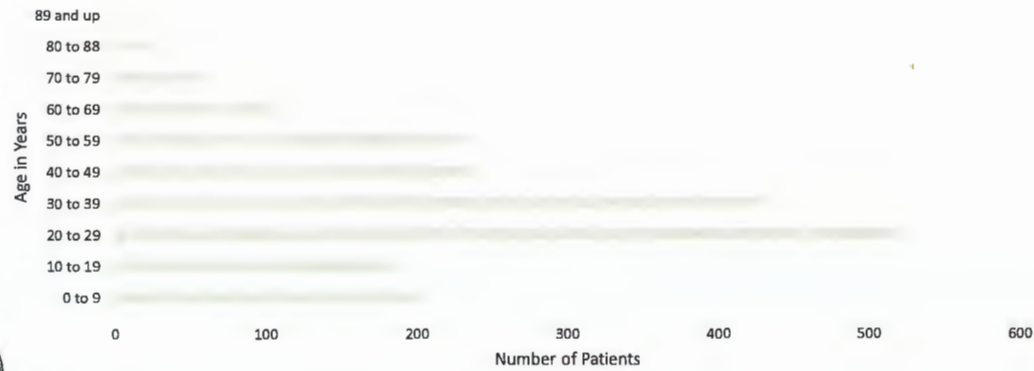
ED Visits for Oral Health as Main Diagnosis By Race, 2017 (Mercy & Beloit)



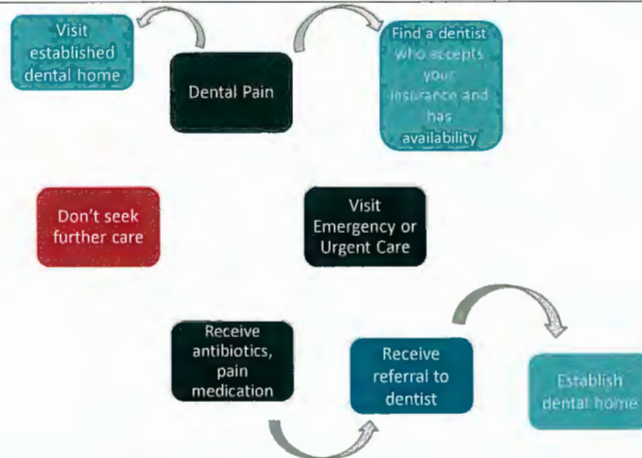

The Patient Experience



Departments and Organizations Setting Precedence

Dane County

Patients get referred to Care Coordinator at More Smiles Clinic, who then reaches out to dental providers to find an appointment

Grant-funded position

Gathered medical doctors, dental providers, representatives from drug injury prevention program, public health to create protocol for best treatment/referral of dental pain patients

Trainings, reviews, pathway to most effective antibiotics and pain management

Standardized template built to easily gather data from different healthcare organizations



Departments and Organizations Setting Precedence (cont.)

Progressive Community Health Centers, Milwaukee

ED makes dental appointment while patient is in the ED

Partnered dentists have one slot blocked every day for a referral patient

La Crosse County Health Department

Care Coordinator position in health department

Working with Dane County, State, Wisconsin Hospital Association, local dental association to replicate Dane County program

Grant-funded position



Next Steps

Create work group with representatives from public health, health systems, FQHCs, free and charitable clinics, dental association, etc.

Health literacy - update current materials from Emergency Departments, create further materials, offer translated versions, etc.

Make sure all EDs offer resources and education in easy-to-understand format

Build referral system, template for gathering data

Try to encourage private practices to take Medicaid patients, offer sliding scale?
