Capt. Maurer called the meeting to order at 9:00AM and asked for introductions be made.

Introductions

Approval of Minutes

Hank Brill motioned to approve the minutes of April 19, 2017. The motion was seconded by Barbara Abraham. Motion passed unanimously.

Fatal Crash Review

With Captain Maurer's recommendation, Hank Brill motioned to move Agenda Item #7, Public Input, to Agenda Item #4. Tom Boguszewski seconded the motion. Motion passed unanimously.

Public Input

Roz Voegeli addressed the group regarding parking along County Road E adjacent to the Tree House Tavern. When the establishment holds an event, patrons park on both sides of County Road E. Roz stated she believed this to be a dangerous situation for her and her neighbors.

The group discussed parking statutes along rural roads. Brian Williams, proprietor of Tree House Tavern, advised parking signs had been set up by his business, however, Sheriff Spoden ordered they be removed.

Duane Jorgenson advised he will research the parking situation more thoroughly and make contact with the area residents by mid-August.

Fatal Crash Review

- **April 1, 2017**: 2 vehicles/1 deceased 78-year-old female. STH 11 @ Austin Road. Video reviewed. No evidence of distracted driving. Toxicology report unavailable as of this date.
- May 1, 2017: 2 vehicles/1 deceased 59-year-old male. STH 59 @ Gould. Video reviewed. No evidence of impairment.
- May 3, 2017: 1 vehicle/1 deceased 38-year-old male. CTH WC & Waveland. Video reviewed. Significant evidence of alcohol, no evidence of speed. Toxicology report unavailable as of this date.
- May 14, 2017: 2 vehicles/1 deceased 45-year-old male. USH 14 & 14 Crossover. Video reviewed. Suspected alcohol use. No safety equipment used. Toxicology report unavailable at this time.
- June 13, 2017: 1 vehicle/1 deceased 35-year-old male. STH 11 @ Janesville Hanover Road. Video Reviewed. Possible medical event prior to crash. No safety equipment used. Toxicology report unavailable as of this date.

Old Business

As an update to the fatality crash at CTH J & Avalon Road, Duane reported the property owners at this intersection have been contacted regarding crop placements. Duane adds land owners have made an effort to remove crops near the roadway.

With regard to the CTH BT and CTH S intersection, Duane advised he is exploring costs to improve the lighting at this intersection.

New Business

Joe Davis distributed information regarding the upcoming Governor's Conference on Highway Safety, August 22-24.

Ryan Mayer provided the group a 7-year collision report on the STH 67 and STH 140 intersection. Most accidents at this intersection occurred on eastbound STH 67 as a result of failure to yield.

Trace Frost advised Community Maps is working on an interface with TraCS, which will upload crash information directly to the Community Maps site.
